Dear Andrew R.T. Davies.

Thank you for your Written Questions 89573 of 10 November and 89629 and 89630 of 15 November, relating to water quality. Further to the interim responses issued on 27th November, please find further substantive responses as follows.

First, your question WQ89773 "To what extent did the Welsh Government consult with companies operating as New Appointments and Variations over its Strategic Priorities and Objectives Statement to Ofwat, which would limit competition in the provision and operation of water and wastewater networks?". Section 2B(4) of the Water Industry Act 1991 sets out the list of statutory consultees when publishing a Strategic Priorities and Objectives Statement. Companies operating as New Appointments and Variations are not specifically listed. Nevertheless, we shared our draft SPS to Ofwat with the relevant NAV in Wales, as part of the process.

Second, your question WQ89629 "What assessment has the Welsh Government made of the consequences of the storm overflow report being published 7 months late?". There have been no adverse consequences from the timing of the publication of the storm overflow report. We have been clear that we are taking an evidence-based holistic approach to tackling all sources of pollution that affect our water bodies. The Storm Overflows Evidence for Wales (SOEfW) Report is one important piece of evidence under a wider action plan. We are considering the report alongside several other elements such as Natural Resources Wales' storm overflow guidance, the water company draft business plans and environmental drivers.

Finally, your question WQ89630 "Will the Minister provide a timeframe for when the Better River Quality Taskforce will publish its targets which are informed by the storm overflow evidence for Wales report?" The Better River Quality Taskforce is reviewing the SOEfW Report with a view to developing an achievable and affordable short-, medium- and longterm programme for the prevention of ecological harm of our riverine waters. The Taskforce will decide the format of the plan, including any associated targets. The programme and priorities will be communicated more widely in due course.

- 1. Andrew RT Davies has tabled a series of Written Questions recently around New Appointments and Variations and our SPS to Ofwat (89573) and the Storm Overflow Evidence for Wales (SOEfW) Report (89629 + 89630).
