Therefore as we do not hold the information at the level of detail requested answering this question would incur disproportionate cost.

The Minister for Health and Social Services (Mark Drakeford): The Liverpool Care Pathway is not used within the NHS in Wales. Our health professionals have worked collaboratively with Health Boards and Voluntary Hospices and have developed the Welsh 'Integrated Care Priorities'. This is a patient centred approach, which stresses the importance of the wishes of the patient and family in determining the care the patient receives when they know they are dying. It is designed to provide comfort and care to both the patient and their carers, once it is accepted by all involved that death is imminent.

The Palliative Care Implementation Board is considering the recommendation of the "Neuberger Review" into the Liverpool Care Pathway in England and any learning this has for Wales. An initial assessment can be found on the Wales Palliative Care Information Website. This also contains more information on the Integrated Care Priorities Approach.

To assist communication and planning Welsh Government is liaising regularly with Chief Fire Officers, senior representatives of other emergency services and the Local Resilience Fora through the Joint Emergency Strategic Group.
