#### **Background**

The National Assembly for Wales unanimously agreed a motion signed by the four party leaders to apply for admission to membership of the Commonwealth Parliamentary Association (CPA) on 7 July 1999. Wales was formally welcomed into the CPA at the General Assembly meeting in Trinidad on 19 September 1999.

The Branch Executive meets at least once a term, on the basis that any other Branch Members who wish to be present are also welcome to attend, with prior notification requested if possible.

#### Note:

This report, due to last year's National Assembly for Wales election and the decision to change the timing of the Branch AGM, covers a longer than usual 18 month period and some activities of the former Branch towards the end of the Third Assembly.

I was elected as a new Chair to our CPA Branch last June. During this past year I have learned much, not only about the historical work and influence of our own Branch, but also of the wider Association and the opportunities for good presented through our membership of the CPA, including a platform to showcase the National Assembly for Wales as a small but leading and innovative international legislature.

I have been encouraged by the interest in the work and activities of our Branch by Members, and in particular by those Members elected to the Assembly for the first time last year.

Our Membership also enables us as a Branch to offer opportunities to young people here in Wales and I'm pleased of the Branch's decision to work more strategically with the Assembly's Outreach and Education services during this past year to source suitable young people through their network of contacts and stakeholders. This has resulted in the CPA Wales Branch being represented very enthusiastically at events such as Commonwealth Day and a Youth Parliament in Westminster, as well as participation in our very own successful Commonwealth debate in Siambr Hywel.

The Branch has also continued its interest, and participation in the discussion, to positively influence the governance of the CPA and we were pleased to support the election, in July of last year, of Sir Alan Haselhurst MP to the position of Chair of the Association. Sir Alan visited the National Assembly this March and has made clear his commitment to working towards ensuring that the CPA is transparent and accountable whilst looking after the best interest and needs of its members and remaining fit for purpose.

The CPA Wales Branch Executive Committee held nine formal meetings during the period of this report. ## <u>CPA Working Party and Executive Committee Meetings - Yukon,</u> Canada (February 2011)

Former Branch Chair Janet Ryder represented the British Isles and Mediterranean (BIM) Region at meetings of both the CPA Working Party and International Executive Committee.

### Commonwealth Day 2011 (March)

An evening reception was held in the Senedd to celebrate Commonwealth Day 2011, the theme of which was "Women as Agents of Change". The event was sponsored by the CPA Wales Branch and jointly organised with Cardiff Council to coincide with the prestigious Commonwealth Local Government Forum Conference (CLGF) which the City hosted.

The Branch was also represented at the official Commonwealth Day celebrations in Westminster by two young people - Bradley Morgan and Jade Mills - from "Funky Dragon".

<u>Visit by a delegation from the Canadian Parliament</u> (March 2011). The National Assembly for Wales hosted a federal delegation representing both Houses of the Canadian Parliament for their first visit to Wales as part of a Canada-UK Inter-Parliamentary Association visit. The visit allowed the opportunity for our two legislatures to learn from each other and exchange best practices in key areas of mutual interest, such as citizen participation, e-democracy and working bilingually. The CPA Branch Chair and Executive Members also met the delegation to discuss CPA related matters.
