The Deputy Minister for Social Services (Gwenda Thomas): I set out my vision for social services in 'Sustainable Social Services for Wales: A Framework for Action' and this made it clear that doing everything 22 times is no longer an option. I expect to see local authorities planning and commissioning services, particularly those specialist services that require high cost placements, on a regional basis. An example of this is the North Wales Commissioning Hub – established in 2012 as a formal partnership between the six North Wales Local Authorities and Betsi Cadwaladr UHB, to commission a specific range of complex social care, education and health services for children and adult residential placements. In addition, our Learning Disability commissioning guidance encourages joint working and notes that the quality and cost effectiveness of services can be significantly improved when organisations work well together.

The establishment of the Regional Collaboration Fund complements very well the approach I want to see. The Minister for Local Government and Government Business has recently agreed over £6m funding for projects under the Fund. The overall aim of the Fund is to bring about real and significant change at a regional level, by acting as a catalyst and, if appropriate, removing barriers such as upfront costs for the implementation of collaboration projects. The bids which have been submitted to date have shown an ambition to improve services, strengthen their resilience and deliver savings across regional and organisational boundaries - projects include local government, health and the police. Alongside acting as a catalyst for innovative projects the Fund also aims to encourage a change of culture. Direct feedback

has indicated public service leaders, executives and officers alike have recognised the need to collaborate and are increasingly acting on this basis, actively seeking out opportunities to work together.

A number of bids have been submitted under the Fund that will provide support to vulnerable groups including those with leaning disabilities/complex needs. The Minister for Local Government and Government Business is considering these bids and will make an announcement shortly.
