Mae'r Cynulliad hwn yn croesawu datganiad Canghellor y Trysorlys am ddileu dyledion y 41 o wledydd sydd wedi'u cynnwys yng nghynllun y Gwledydd Tlawd Trwm eu Dyledion (GTTD), ac yn credu y dylai'r Canghellor gymryd y camau canlynol ychwanegol i leihau'r baich o ddyled ar bobl dlotaf y byd:

- *pwysu dros gynnwys yng nghynllun lleddfu dyledion y GTTD bob un o'r 52 o wledydd a enwyd gan Jiwibili 2000*
- *galw ar y G7 i gynnal cyfarfod arbennig cyn gynted â phosibl eleni i drafod dyled*

This Assembly welcomes the Chancellor of the Exchequer's announcement of debt cancellation for the 41 countries included in the Heavily Indebted Poor Countries (HIPC) initiative, and believes the Chancellor should take the following additional steps to ease the burden of debt on the world's poorest people:

- *press for all 52 countries named by Jubilee 2000 to be included in the HIPC debt-relief scheme*
- *call on the G7 to hold a special meeting as early as possible this year to discuss debt*

- gynyddu eu lwfansau yn aruthrol cyn ystyried yr Adroddiad sydd ar fin cael ei gyhoeddi gan Gymdeithas Llywodraeth Leol Cymru (CLILC) ar y mater hwn, a;
- gwrthod caniatáu cyfle i'r Cyngor llawn gymeradwyo neu newid codiadau o'r fath.

Ymhellach, mae'r Cynulliad hwn yn annog Arglwydd Faer Caerdydd a chabinet y Cyngor i:

- ofyn i Gomisiwn Parkinson sicrhau bod ei gasgliadau yn gyson â'r canllawiau a bennir gan Adroddiad CLILC pan y'i cyhoeddir, ac yn y cyfamser;
- gwrthod y lwfansau ychwanegol tan y bydd Comisiwn Parkinson wedi cyhoeddi cynigion newydd i'r Cyngor llawn eu hystyried.

This Assembly censures the cabinet of Cardiff County Council for:

- implementing massive increases to their allowances before considering the impending WLGA Report on this issue, and;
- refusing to allow full Council an opportunity to approve or amend such increases.

Furthermore, this Assembly urges the Lord Mayor of Cardiff and the Council cabinet to:

- ask the Parkinson Commission to bring its findings into line with guidelines set by the WLGA Report when published, and in the meantime;
- refuse additional allowances until the Parkinson Commission has returned with fresh proposals for consideration by the full Council.

- gael gwared o wahaniaethu yn erbyn menywod drwy ddiddymu cyntafanedigaeth
- diddymu gwahaniaethu yn erbyn Catholigion drwy gael gwared o'r darpariaethau sy'n gwahardd Catholigion a rhai sy'n briod â Chatholigion rhag esgyn i'r Orsedd, ac;

This Assembly believes the laws that govern the succession and coronation of the Monarch need to reflect the values of Wales in the 21st Century. This Assembly urges Parliament to:

- remove discrimination against women by abolishing primogeniture;
- eliminate discrimination against Catholics through the removal of provisions that exclude Catholics and persons married to Catholics from the Throne, and;
- reflect the ecumenical and multi-faith character of Wales and the UK by amending the coronation oath to replace the duty of the sovereign to uphold the "*Protestant religion*" with a commitment to uphold Christianity and respect all recognised faiths.

publication of the Members' Allowances Working Group Report *Rewarding Community Service* commissioned by the former Secretary of State for Wales, and if this is not forthcoming, call on;

- the executive to introduce an Assembly Order to cap excessive allowances in local government.
