The Minister for Business, Enterprise, Technology and Science (Edwina Hart): The Welsh Government is interacting with stakeholders to develop a sustainable management plan for the Three Rivers Estuary. This plan will consider the merits of restricting permit holders by using the powers within the Marine and Coastal Access Act 2010. We will consider the merits of a restricted permit scheme, together with any other proposals from stakeholders, including the possibility of a Regulating Order. Due to recent events stocks have fallen to a level which do not currently allow for a Fishery. Therefore a decision has been made to close the cockle fishery until at least 5 September 2011.

The Minister for Health and Social Services (Lesley Griffiths): I am advised by the Food Standards Agency (FSA) as Competent Authority in the UK for genetically modified animal feed (and food) matters that only authorised GM materials may be present in any feed (or food) marketed in the EU, whether imported or produced domestically.

EU Regulation 1829/2003 lays down the rules for the authorisation and labelling of genetically modified food and feed. Under these rules GM feed and food can only be marketed in the European Union after undergoing a rigorous safety assessment by the European Food Safety Authority (EFSA). The objectives are to provide the basis for ensuring a high level of protection of human health, animal health and welfare, environment and consumers' interests in relation to GM food and feed.

On this basis I am satisfied that animal feed containing GM material on the market is safe and poses no threat to public health.

In 2009, a total of 30 items were reported stolen with an estimated value of £11,680. In 2010, a total of 13 items were reported stolen with an estimated value of £1,535. The stolen items include both staff personal belongings and Welsh Government property. There have been no items reported as being stolen from Welsh Government premises in 2011 to date.

The guide will be published shortly.

In addition, some of the TrawsCambria longer-distance bus services offer audio-visual announcements and I am keen to extend coverage as part of our plans for expanding and improving the quality of the TrawsCambria network.
