## Request for Information.

Thank you for your request received on 20 January in which you asked.

- 1) The overall cost of renovating the entrance area of the Tŷ Hywel building;
- 2) An itemised breakdown of all costs incurred in the renovation;
- 3) The cost of the slate benches in the entrance area of the Tŷ Hywel building.

Over 30,000 visitors are welcomed to our estate via Tŷ Hywel's reception each year. Over half of these visitors are children and young people, often arriving in large parties and engaging with our education programme based in Siambr Hywel.

The Commission's budget document for 2013-14, available <a href="here">here</a> set out the importance of the Assembly Commission providing a 'venue for Wales' through the Assembly's estate, and prioritising the need to continue to maintain our buildings to a high standard to provide a great experience for our visitors.

The construction of this covered entrance is a practical and modest solution to address the issues of access, security and sustainability.
