Citation and commencement

1.-(1) These Regulations may be cited as the Housing Renewal Grants (Prescribed Form and Particulars) and (Welsh Form and Particulars) (Amendment) (Wales) Regulations 1999 and shall come into force on 1999.

(2) These Regulations extend to Wales only.

Amendments

2.-(1) The form set out in the Schedule to the Housing Renewal Grants (Prescribed Form and Particulars) Regulations 1996^(d) is amended as set out in Schedule 1 to these Regulations;

(2) The form set out in the Schedule to the Housing Renewal Grants (Prescribed Form and Particulars) (Welsh Form and Particulars) Regulations 1998^(e) is amended as set out in Schedule 2 to these Regulations.
