Request for Information

Thank you for your request for information, received on 04 October, in which you asked,

Could I have a copy of the assessment carried out on the cost of passing amendment 9 to the Official Languages Bill, moved in the name of Aled Roberts?

The following is the information that was used in assessing the cost of passing amendment 9 to the Official Languages Bill. (For information – The number of words that need to be translated in every Record is approximately 37,000).

Figures for translating the Record within 5 days

The cost is estimated using the current rate of £50 per 1,000 words translated using machine translation with post-editing.

- The cost of translating plenary proceedings from English into Welsh therefore would be £50 \times 37 = £1,850.
- The cost of translating 66 Records per annum would be £122,100.

Figures for overnight translation of the Record

We do not have a rate available for translating using machine translation with post-editing work overnight. Therefore we used the current rate payable for

Bae Caerdydd Caerdydd CF99 1NA Cardiff Bay Cardiff CF99 1NA text translation within 24 hours of £93 per 1,000 words. This rate is part of the Assembly's translation call off contract.

- The cost of translating each Record within a 24 hour period would be $93 \times 37 = £3,441$.
- The cost of translating 66 Records per annum would be £227,106. Therefore, the cost of publishing simultaneously is an additional £105,006 (£227,106 £122,100)

You refer in your email to a figure of £600k. The Commissioner with responsibility for the Welsh Language, Rhodri Glyn Thomas AM, first mentioned this figure as an approximate cost for translating contributions to committee proceedings from English to Welsh in a letter to Bethan Jenkins AM which was published on 12 June. These services were discussed during the debate on Aled Roberts' amendment on 3 October. A link to the relevant section of the Record is available here.
