Dear Andrew,

I write further to your Written Question 93398 requesting a full breakdown, including monetary figures for a) all research projects; b) all advertising projects; c) all events; d) grants for organisations; e) grants for local authorities; and f) all other further funding allocations, as part of the Nation of Sanctuary plan since its inception.

The table at Annex A provides the information collated. It has not been possible to provide a breakdown in line with the categories outlined in your question due to the way expenditure was recorded. Nevertheless, the funding provided is inclusive of the various categories you have outlined.

Please note the Nation of Sanctuary policy includes an explicit focus on mainstreaming access to services within mainstream schemes so some of the expenditure is not recorded separately to general costs.
