Motions tabled on 13 June 2006

Minority Party Debate

NDM3100 Jocelyn Davies (South Wales East)

To propose that the National Assembly for Wales:

1. Acting in accordance with its powers under Section 1 of the Inquiries Act 2005, causes an inquiry to be held into the provision of ambulance services in Wales;
2. Recommends that the terms of reference for the inquiry should be:
 - a) to look at the effectiveness of performance standards, staffing issues, financial and resource pressures together with any other related matters considered relevant; and
 - b) to consider the implications for the future and make recommendations accordingly;
3. The cost of the inquiry shall be borne by the Welsh Assembly Government.

Kirsty Williams (Brecon and Radnorshire)

Add as new point 3 and renumber accordingly:

Calls for a panel, comprised of the Assembly Minister for Health and Social Services, and one Member each from the Welsh Liberal Democrat Party, the Welsh Conservative Party and Plaid Cymru the Party of Wales, to be convened for the purpose of recommending the name of a suitable person to chair the inquiry. The panel shall lay a report before the Assembly accordingly.

Believes that the composition of the Residential Property Tribunal should represent public-private sector balance.

Regrets the recent significant increase in the number of households in Wales experiencing fuel poverty.

6. Jocelyn Davies (South Wales East)

Add new point at end of motion:

Calls on the Welsh Assembly Government to introduce a comprehensive energy efficiency scheme aimed at reducing energy consumption.

7. Jocelyn Davies (South Wales East)

Add new point at end of motion:

Condemns the refusal of the Welsh Assembly Government to release statistics to demonstrate whether the Communities First programme is achieving its aims.

8. Jocelyn Davies (South Wales East)

Add new point at end of motion:

Regrets the persistent high levels of in-work poverty in Wales.

9. Jocelyn Davies (South Wales East)

Add new point at end of motion:

Notes with concern the failure of the Welsh Assembly Government to honour its commitments in the National Service Framework for Mental Health in Wales.

Add new point at end of motion:

Welcomes the fact that this is the last social justice report of the Assembly term and looks forward to future independent assessments of the Assembly Government's social justice record.
