Notes the inclusion in the Programme of two Wales-only Bills and regrets that the legislative logiam at Westminster prevents the introduction of more Wales-only bills;

Amendment 3 - David Melding (South Wales Central)

Delete point 2 and replace with:

Regrets the failure of the Welsh Assembly Government to secure more than two Wales-only Bills.

Amendment 4 - David Melding (South Wales Central)

Add new point 3 and renumber accordingly:

Believes that the following list of Wales-only Bills would have better reflected Welsh needs and concerns:

- a) Culture (Wales) Bill to establish a National Gallery and National Archive for Wales.
- b) NHS (Wales) Bill to introduce a "patients' passport" scheme to reduce waiting lists.
- c) Education (Wales) Bill to encourage the development of specialist schools in Wales, starting with Welsh and modern foreign language schools.
- d) Housing (Wales) Bill to allow groups to set up loan funds and establish neighbourhood associations with a view to providing more affordable housing.
- e) Bank Holiday (Wales) Bill to establish St David's Day as an official public holiday in Wales.
- f) Mental Health (Wales) Bill to reform existing legislation and shift the emphasis to therapy rather than criminal law in relation to serious mental health issues.
- g) General Provisions (Wales) Bill to allow miscellaneous matters recommended by the assembly for primary legislation to be consolidated into a single Bill.

Amendment 5 - Kirsty Williams (Brecon and Radnorshire)

Add new point at end of motion:

Regrets the lack of a Government of Wales Bill to implement the recommendations of the Richard Commission to give the Assembly primary law-making powers and calls on the Assembly Government to press the UK Government to bring one forward as soon as possible.

Add new point at end of motion:

Notes the inclusion in the Queen's Speech of the Transport (Wales) Bill which has been lobbied for by the Assembly Government for 3 years in succession.

Welcomes the commitment of the Scottish Executive not to require ID Cards to access devolved public services in Scotland and calls on the Assembly Government to make the same commitment for Wales.
