We will continue to work with partners on a potential bid and will take full account of the costs and benefits of the 2014 games in Glasgow ahead of any final decision regarding a bid.

The Minister for Education and Skills (Leighton Andrews): The results published on the 4 October are provisional and, following checks with schools, could be subject to revision before final publication in early December. It is too early to say that the gap between pupils in England and Wales has widened in 2012 because provisional English results for 2012 are not published until 18 October and these will also be subject to revision before final publication in January.

The data for pupils attaining 5 GCSEs between grades A*-C is represented in the data published on 4 October as the Level 2 threshold. However, not all learners counted as having achieved this threshold will have passed 5 GCSEs at A* to C. The present equivalence-based system allows some vocational qualifications to attract heavy weightings in performance terms; up to four GCSEs in many cases. These equivalent qualifications increased the Level 2 inclusive threshold differences between Wales and England from 4.0 per cent for GCSE and GCSE Short Course to 8.8 per cent overall in 2011.

The Minister for Health and Social Services (Lesley Griffiths): An All Wales Sleep Apnoea Working Group, comprising of respiratory consultants delivering sleep apnoea services in NHS Wales, produced a proposal for minimum clinical standards for sleep apnoea in Wales.

The recommendations of the group were accepted and the advisory document 'Sleep Disordered Breathing Services in Wales' was issued to Chief Executives in February 2011 to assist Health Boards in planning for improved sleep services.

Lesley Griffiths: Prostate cancer patients in Wales have access to a range of well-established and effective treatments.

Robotic surgery for treatment of prostate cancer is currently being evaluated as part of the UK Health Technology Assessment Programme with findings expected to be reported later this year. The All Wales Cancer Implementation Group has recently considered a report by the National Specialist Advisory Group for Cancer Urological Cancer Subgroup on robotic surgery for patients with prostate cancer. Given this treatment is a relatively recent innovation, it is not currently available in Wales. This may change as more evidence on its effectiveness becomes known. Where a patient is thought to need a treatment that is not normally provided by the NHS in Wales, then they can make an Individual Patient Funding Request application to their Health Board, via their doctor.
