Fire Service Pay

This Assembly believes:

- *That a national fire service strike would put lives at risk across Wales*
- *That there is still time to avoid industrial action in the fire service, but that time is running out fast*
- *A professional fire service requires a professional pay structure*
- *All sides have a duty to leave no stone unturned in the attempt to reach a negotiated settlement of the present dispute*
- *The National Fire Service Employers should immediately return to negotiations with the Fire Brigades Union with the aim of agreeing a correct, professional level of pay for the fire service*
