# Amendment 2: Peter Black (South Wales West) R

## Add at end :

That in considering further the preliminary draft budget the Assembly Committees and Executives should have regards to the need to reduce class sizes for 7 - 11 year olds, reduce the backlog of school maintenance and reduce waiting times for health services

## Amendment 3: Glyn Davies (Mid & West Wales) R

# After the sentence ending "Edwina Hart." add:

"However, this Assembly regrets that:

- resources for NHS Trusts and Health Authorities will be cut by £4.7 million at a time when these bodies are experiencing severe financial difficulties;
- insufficient funds will be allocated to help new entrants into farming; and,
- the £15 million set aside from the *Pathways to Prosperity Fund* for use as Objective One match funding is not additional money, but cash diverted from an existing fund that has already been earmarked."

#### Petition received on 10<sup>th</sup> November 1999

A petition was received from the Countryside Alliance; the British Association for Shooting and Conservation (Wales); the Farmers Union of Wales; the National Farmers Union (Wales); and the Country Landowners Association (Wales).

The full text of the petition reads:

"Letter of Petition

The Countryside Alliance, Country Landowners Association (Wales), National Farmers Union, the Farmers Union of Wales and the British Association for Shooting and Conservation represent 1 million members. The Welsh supporters, many of whom have walked through the heart of Wales to a new Parliament, at the National Assembly for Wales, come to express their increasing concerns that rural opinion is not being heard and individual liberty is threatened.

These rural issues encompass many interrelated areas such as agriculture, the right-to-roam, rural investment, social exclusion, unnecessary restrictive laws on shooting and the touch-paper for the demonstration today, the threat to hunting.

The people of Wales care deeply for their countryside and wish it to be a living heritage for future generations. We demand therefore, that of those elected to govern our "One Nation" do so with understanding and tolerance. We, who represent the Countryside, present ourselves on the doorstep of the Government in Wales, with a clear message also for the Government of Great Britain and Northern Ireland; that when faced with deciding on the priorities for rural Britain, you must:

"Choose Livelihood"."
