# **Debate on the National Library**

- supports the National Library's proposal to undertake a large scale extension in the collections and services which it provides remotely, mainly in digital form over the Internet, to users in Wales and around the world;

- endorses the policy of the New Opportunities Fund to provide financial assistance to enable all public libraries, where practicable, to be on-line and linked to the National Grid for Learning by the end of 2002;
- encourages all public library authorities, and the National Library, to consolidate and develop their role in tackling social disadvantage and providing opportunities for learning
