The Minister for Health and Social Services (Lesley Griffiths): A Respiratory Delivery Plan is being developed for launch in 2013. The delivery plan will include sleep apnoea as a core component.

In 2010 an All Wales Sleep Apnoea Working Group, comprising of respiratory consultants delivering sleep apnoea services in NHS Wales, produced a proposal for minimum clinical standards for sleep apnoea in Wales. The recommendations of the group were accepted and the advisory document 'Sleep Disordered Breathing Services in Wales' was issued to the Chief Executives of all Health Boards in Wales in February 2011, to assist them in planning for improved sleep services. The Respiratory Delivery Plan will review the implementation of this guidance.

Lesley Griffiths: The Wales Air Ambulance provides a greatly valued service to people across Wales and the support of the public has been instrumental in this. The current position with funding of Air Ambulance services in Wales is the Welsh Government provides central funding for the salary costs of paramedics working on the air ambulances, whilst the operational costs of the helicopters are funded through charitable donations from the Air Ambulance Charity.

The Charity has not made a request to the Welsh Government to provide additional funding for this service and continues to meet operational costs through public donations and support.

Lesley Griffiths: In October 2012, 59% of patients were handed over from ambulance crews to emergency department staff in 15 minutes.

Since January there has been a 14.3% increase (22,419 patients) in the number of patient handovers at emergency departments compared to the same period last year. This is a reflection of the unusual and persistent emergency pressures on the NHS since last winter. Despite this increase in the number of patients the vast majority (83%) were handed over within 30 minutes.

Lesley Griffiths: Discharging at least 20% of patients who are clinically ready before 11:00 a.m. creates bed capacity and contributes to reducing delays at Emergency Departments for patients who require emergency admission.

Further, discharging patients from hospital who are clinically ready to leave as early as possible, has a major impact on patient flow and the effective use of bed capacity, which will result in fewer cancellations of elective procedures and allow patients who require surgery to be admitted more efficiently.

- £1 million retained for initiatives by the National Urgent and Emergency Care Board.
