Debate on Part 7 Order under Section 59 of the Town & Country Planning Act 1990 (to allow the economic diversification of existing agricultural buildings to allow their conversion to light industrial or business use without the need to make a planning application, by amending the Town

& Country Planning Act 1990 (General permitted Development) Order 1995

The Assembly resolves to instruct the Assembly Secretary for Environment, Transport and Planning to bring forward a draft Order under section 59 of the Town and Country Planning Act 1990. The objectives to be achieved by this Order are:

- To enable economic diversification of agricultural buildings which have been in agricultural use for 5 years or more by amending the Town and Country Planning (General Permitted Development) Order 1995
- To confer permitted development rights on agricultural land comprising an agricultural unit of at least 5 hectares so that existing agricultural buildings on the land can be redeployed by i) applying the uses which fall within Class B1 of the Town and Country Planning (Use Classes) Order 1987 and ii) allowing modifications and limited extensions to those buildings as necessary for such redeployment

The Order to apply to the whole of Wales

Debate on the future of the Water Utilities in Wales

To propose that the Assembly recognises the importance of the Hyder Group and the regulated water and electricity utilities to the economy, environment and infrastructure of Wales; it welcomes and endorses the actions of the First Secretary and the Environment Secretary in meeting and seeking reassurances from any potential purchasers of Hyder with respect to the safeguarding of the integrity of the Group, its employees and the environment in Wales, and the protection of the interests of Welsh consumers; and it notes the proposed actions of the water and electricity industry regulators in seeking commitments and licence amendments to protect the interests of customers and the continued delivery of the investment programmes of the regulated utilities

privatised water utility, and calls on the Environment Secretary to bring forward proposals to protect the interests of both of this valuable natural resource and those of water consumers in Wales.'
