**The Minister for Local Government and Government Business (Lesley Griffiths):** The Welsh Government's agenda, through the "Fire and Rescue National Framework 2012 Onwards", is to ensure the safety of fire-fighters and Welsh Citizens. This includes the "Welsh Government's Guiding Principles on Dwelling Fire Response Standards" published in March 2012 which puts citizen and fire-fighter safety at the forefront of Fire and Rescue Authorities' (FRA) planning considerations.

I committed to issue a Written Statement this month on this issue.

**Lesley Griffiths:** Fire fighters' fitness is part of the Welsh Government's agenda for the Fire and Rescue Services (FRSs) in Wales and the "Fire and Rescue National Framework 2012 onwards" sets out the requirement for the FRSs to ensure the safety of fire-fighters and Welsh Citizens.

The First Minister wrote to the Chairs of the Fire and Rescue Authorities (FRAs) in Wales on 16 September, requesting they work collaboratively with Welsh Government to develop a common fitness standard in Wales, with the FRAs, as employers and representative bodies, playing their part.
