The Deputy Minister for Agriculture, Food, Fisheries and European Programmes (Alun Davies): I attended the last meeting of the EU Council of Agriculture Ministers on 20 September 2011 as part of the UK Ministerial team. I had an introductory meeting with the EU Agriculture Commissioner, Dacian Ciolos and prior to the Council meeting held discussions with the Defra Minister of State, Jim Paice, about CAP reform.

I also met with Welsh MEPs and briefed them on the issues affecting the Welsh Agriculture and Fisheries industries and discussed how they and the Welsh Government can best work together to represent the interests of Wales.

Items discussed at the formal meeting included CAP reform in relation to the future of the EU food distribution programme and the strengthening of EU crisis management tools.

I will be attending the next Council meeting on 20 and 21 October to discuss formal CAP reform proposals which we expect the Commission to publish on 12 October.

The Minister for Environment and Sustainable Development (John Griffiths): We are aiming to have a small number of highly protected Marine Conservation Zones in Welsh territorial waters in order to support marine ecosystem recovery, enhance resilience and improve our understanding generally of the marine environment. In this context, 'highly protected' is where all depositional and extractive activity is excluded, along with any other damaging or disturbing activity.

We expect to be in a position to designate the zones in early 2013, subject to a comprehensive and iterative public consultation exercise starting in early 2012. We have established the Marine Conservation Zone Project Wales to take forward this work, which is currently at the stage of identifying potential sites for the first stage of consultation early next year.

However, some schemes across Wales have had to be delayed as a consequence of the capital reduction. My officials continue to work with the Health Boards and Trusts to manage this in the light of their 5-year Service and Financial Frameworks.
