This has resulted from the need to embed new ways of working surrounding the implementation of a new procurement system.

**Andrew Davies (South Wales Central):** With reference to her answer to WAQ56849, will the Minister explain the significant increase in the total value of payments recorded for months so far in this financial year 10/11, as opposed to previous years. (WAQ56888)

### Answer issued on 04 January 2011

The increase in the monthly value of payments is due to the incorrect inclusion of public sector funding invoices in the later payment performance figures. These will be removed in the published results.

**Andrew Davies (South Wales Central):** With reference to her answer to WAQ56832, will the Minister provide a breakdown for travel and subsistence claims made by staff and Ministers of the Welsh Assembly Government, with figures for each of the last four years. (WAQ56889)

**Nick Bourne (Mid and West Wales):** Will the Minister detail the cost of security for all Welsh Assembly Government offices in Wales during 07/08, 09/10 and 10/1, with an office by office breakdown. (WAQ56902)

### Answer issued on 04 January 2011

Following clarification, the question has been interpreted as applying to the costs of security guarding on the Welsh Assembly Government's Administrative Estate for the last three full financial years for which information is available.

Uniformed guards provide an important deterrent, although their use is commensurate with the assessed risk and limited to a small number of Assembly Government buildings. These are the larger sites, where there may be a high number of visitors who require scanning and there is judged to be an increased security threat.

Information for financial year 2007/08 is archived following the introduction of a new financial system and could only be gathered at disproportionate cost. Costs for the last two full financial years, for each office with a permanent security guard presence are as follows:

The costs provided in relation to the Aberystwyth office are part year costs only and cover the period from the opening of the office in July 2009 to March 2010.

The new Llandudno Junction office also has a permanent security guard force. However, costs are not included above as the office opened in the current financial year.

In addition to the above, there are estate-wide costs associated with key-holding services and emergency response and patrol services. The breakdown of these costs on an office by office basis could only be gathered at disproportionate cost. However, annual expenditure is:

The proposed running cost budget for the Higher Education Funding Council for Wales is £3,013,000 for 2011-12; £2,908,000 for 2012-13; and £2,768,000 for 2013-14.

## To ask the Minister for the Economy and Transport

**Kirsty Williams** (**Brecon and Radnorshire**): What is the proposed budget for each Assembly Government-sponsored body for which the Minister is responsible for the three years covered by the draft budget. (WAQ56893)

There are no Assembly Government-sponsored bodies that are funded from within the Economy and Transport budget.

**Andrew RT Davies (South Wales Central):** In reference to his answer to WAQ56837, will the Minister provide an explanation as to the discrepancy between the figures provided and confirm which dates the figures relate to. (WAQ56903)

## Answer issued on 08 April 2011

Since 2003 and up to 31 October 2010, £19,210,000 has been spent on airfield operations and related costs in support of the Aerospace Park development at St Athan. This expenditure can be attributed specifically to the development of the aerospace park.

An additional £24,776,000 has been spent during the same period on site remediation, land assembly, facilities management, legal and professional fees, highway and utilities design work. These are whole site development costs.

For the sake of completeness, it may be helpful if I explained that £2,676,000 was also spent on the Defence Technical College proposal between 2007 and 31 October 2010.

Overall, therefore, a total of £46.6 million has been spent since 2003 on the St Athan site.

Andrew RT Davies (South Wales Central): Will the Minister give an update on the provision of dental services in relation to the new dental contract and the ability of Local Health Boards to commission new

dental services allowing dental practices to expand to meet demand within the NHS in Wales. (WAQ56905)

### Answer issued on 15 December 2010

The ability of patients to access NHS dental services has improved significantly since the new dental contract was introduced. Local Health Boards have responsibility for the provision of dental care to meet local needs and for the control and accountability of their dental budget; this must be achieved through a finite general dental budget allocation.

Where a contract ceases, for whatever reason, the financial value of the contract does not return to the Assembly Government but remains with the LHB to reinvest in the provision of alternative dental services. Change to the provision of dental services, such as expansion, is a matter for the LHB to determine in conjunction with providers as part of their planning and development of services.
