# European Parliament and Welsh MEPs 2009-2014

June 2011

#### Introduction

The European Parliament<sup>1</sup> is the only directly-elected body of the European Union (EU).

There are currently 736 Members of the European Parliament (MEPs), who represent the 500 million citizens across the 27 countries ("Member States") in the EU. Approximately one third of MEPs are women at present.<sup>2</sup>

The UK has 72 out of this total, spread across 12 regions. Wales is one of these "regions", and has 4 MEPs.

The life of an MEP is something of a "nomadic experience", split across three main locations:

- Strasbourg, which is the official home of the European Parliament. 12 sittings of the EP are held in Strasbourg each year, which equates to around one week of business per month
- Brussels, the second home of the European Parliament, where most of the Committee meetings take place, together with a number of "mini-plenary" sessions held during the year
- Their constituency, which in the case of the Welsh MEPs means the whole of Wales.

# The 2009 European Parliamentary elections

European Parliamentary elections take place every five years, and the most recent elections took place in June 2009. The current MEPs will serve a term of office until May 2014. The 2009 elections took place across the EU from 4 to 7 June 2009. The results for Wales are shown in the table below.

(b) Turnout is classed as all votes cast (including spoiled papers) as a percentage of the electorate.

In 2009 Labour won one less seat than in 2004, while the UK Independence Party gained a seat, and was elected to represent Wales in the European Parliament for the first time.

Turnout in Wales for the 2009 elections was considerably lower than in 2004, decreasing from 41.9 per cent to 30.5 per cent; a decrease of 11 percentage points. Turnout in Wales and the rest of the UK has consistently been below the EU average, which was 43 per cent in 2009. There is a high level of variation across Member States. Luxembourg saw a 91 per cent turnout, while Slovakia and Lithuania both had turnouts of 20 per cent.<sup>4</sup>

# Welsh MEPs 2009-2014

By party and European Parliamentary political group, the four Welsh MEPs elected in 2009 are:

- John Bufton, UK Independence Party and Europe of Freedom and Democracy Group
- Jill Evans, Plaid Cymru and Greens/European Free Alliance Group
- Dr Kay Swinburne MEP, Welsh Conservatives and European Conservatives and Reformists Group
- Derek Vaughan MEP, Welsh Labour and Group for Progressive Alliance of Socialists & Democrats

As well as being members of one of the seven political groups in the European Parliament, each of the Welsh MEPs sits on one or more of the 20 permanent Committees, which undertake the day to day legislative and policy scrutiny work of the European Parliament. They may also be selected by their political groups to sit on the special or "temporary" Committees that are established in response to issues of particular political significance for the EU, e.g. the financial crisis or to prepare for the discussions on the future multiannual EU budget.

Finally, the Welsh MEPs may engage in various formal and informal working groups in the European Parliament, and external representative work.

The following sections give a brief resume of the Committees, working groups and other external activities that the four Welsh MEPs are involved in<sup>5</sup>.
