In order to find this information on our **allowances system**, please follow these instructions:

- 2. To select a specific Member of the Senedd, select 'MEMBER PICKER' and view the list of previous and current Members and select Lee Waters.
- 3. To select the specific expense type, select the 'ALLOWANCE TYPE PICKER' and select the following:
 - a. 'Mileage'
 - b. 'International Travel'
 - c. 'UK Travel'
 - d. 'Family Travel'
 - e. 'Additional Costs Allowance'.
- 4. Select 'Search'
