**MEMORANDUM OF CORRECTIONS PURSUANT TO STANDING ORDER
22.12A**

Disabled Persons (Badges for Motor Vehicles) (Wales) Regulations 2000

Background

These Draft Regulations were laid before the National Assembly for Wales on 26th May 2000, considered by the Business Committee on 24th May 2000 and by the Legislation Committee on 6th June 2000.

Typographical and drafting errors were identified by the Legal Advisers to the Legislation Committee prior to the Committee's meeting and amendments were suggested in consequence.

The amendments set out below were reported to the Legislation Committee at its meeting on the 6th June and agreed by it for consideration by the Assembly:-

Amendments

Arrangement of Regulations

Amendment 1

After "Rhan I" under "Yr Atodlen" remove superfluous colon.

Regulation 2

Amendment 2

In the definition of "disabled person" insert "who" before "corresponds".

Reason for the amendment:

To make the intention clearer and improve sentence construction.

Amendment 3

In the definition of "holder" remove the superfluous comma after "deiliad".

Regulation 3(2)(a)

Amendment 4

Insert "a local authority" after "any application made to".

Reason for the amendment:

To make the meaning clearer following the more straightforward construction of the Welsh text.

Regulation 9

Amendment 5

Remove duplicated semi-colon at the end of 9(1)(b) of the Welsh text and insert semi colon at the end of 9(1)(b) of the English text.

Amendment 6

Remove duplicated semi-colon at the end of 9(1)(c) of the English text.

Amendment 7

Replace semi colon with full stop at the end of 9(1)(dd) of the Welsh text.

Amendment 8

Insert full stop at the end of 9(2)(b) of the Welsh text.

Reason for amendments 5 to 8:

To improve consistency of punctuation.
