The Commencement Order No. 2 brings into force, from 1 April 2005, all of the provisions of the Public Audit (Wales) Act 2004 (with the exception of section 54 (1) to (5)) not commenced on Royal Assent or by the Public Audit (Wales) Act 2004 (Commencement No.1) Order 2005. The first Commencement Order was approved by the National Assembly on 18 January 2005 and came into force on 31 January.

• The Products of Animal Origin (3rd Country Imports)(Wales) Regulations 2005

These Regulations revoke and remake, with changes the Products of Animal Origin (Third Country Imports) (Wales)

Regulations 2004 for reasons of clarity and introduce amendments to give effect to recent changes to EU import requirements.

The Diseases of Animals) (Approved Disinfectants) (Amendment) (Wales) Order 2005

These Regulations update the list of approved disinfectants through an amendment to the Diseases of Animals (Approved Disinfectants) Order 1978 (as last amended in 2001) for reasons of clarity and introduce amendments to give effect to recent changes to the list of disinfectants put forward by the industry. The approved disinfectants are to be used in the control of specific animal diseases such as Foot and Mouth, Swine Vesicular disease, Bovine TB and diseases of Poultry such as Avian Influenza.

• The Salmonella in Laying Flocks (Survey Powers) (Wales) Regulations 2005

The making of these Regulations is necessary to enforce a survey of laying hens, provides power of entry and related powers for the purpose of carrying out a survey to ascertain levels of zoonotic (bacterium, virus, parasites or other communicable agents) Salmonella within laying flocks of domestic fowl.

• The Community Health Councils (Amendment) Regulations 2005

The intended effect of these Regulations is to tighten up membership terms and provide greater flexibility as well as requiring Community Health Councils to adopt a complaints procedure.

• The Dairy Produce Quotas (Wales) Regulations 2005

These Regulations, which are made under section 2(2) of the European Communities Act 1972, consolidate and amend The Dairy Produce Quotas (Wales) Regulations 2002 (S.I. 2002/897 (W.103)). They do not introduce any distinct Welsh provisions because the milk quota regime is a UK wide scheme. The Regulations implement certain corrective changes required to implement European legislation, in particular on the method of calculating the butterfat levy and setting deadlines for receipt rather then despatch of documents, a requirement to keep records of feeding regimes; omitting milk destroyed off farm from the levy calculation; and providing for quota holders to take quota they

have purchased in their own right with them at the end of a tenancy

> Local authorities are required to charge residents for residential accommodation, whether directly provided or arranged with an independent home, with the aim of recovering as much as possible of the costs. The assessment of a person's ability to pay for accommodation is laid down in the National Assistance (Assessment of Resources) Regulations 1992. The Welsh Assembly Government has made a commitment to restore the capital limits for means testing to their 1996 real term value and to keep them under review. Limits are now reviewed annually to ensure they remain broadly in line with inflation. The intended effect of the amendment to these Regulations is to increase the capital limits for means testing in line with inflation for the upper limit from £20,500 to £21,000 and by a significantly higher amount of 9.2% for the lower limit from £13,500 to £14,750. They also reflect changes to income-related benefits from April 2005, which are linked to these Regulations.

 Motion to approve the National Assistance (Sums for Personal Requirement) (Wales) Regulations 2005.

Local authorities are required to charge residents for residential accommodation, whether directly provided or arranged with an independent home, with the aim of recovering as much as possible of the costs. The assessment of a person's ability to pay for accommodation is laid down in The National Assistance (Assessment of Resources) Regulations 1992. The effect of the amendment to the National Assistance (Sums for Personal Requirements) Regulations is to increase the weekly sum, which local authorities are to assume that residents in residential or nursing care will need for their personal requirements, from £18.40 to £19.10 from 2005-06.

 Directions 2005 under Standing Order 29 (15 mins)

In the context of the increased threat of terrorism, these Directions are necessary to

restrict information associated with the location of radioactive materials from being

placed in the public domain. "

(Amendment) (Wales) Regulations 2005 (15 mins)

These Regulations further amend the National Health Services (Pharmaceutical Services) Regulations 1992 (SI 1992/662); this regulates the terms on which pharmaceutical services are provided under the National Health Service Act 1977. These Regulations establish a new Pharmacy Contract framework which is key to developing new initiatives in community pharmacy. It is anticipated that community pharmacies will provide a greater range of services and be rewarded for quality and not just the volume of prescriptions dispensed.

The new contract will enable community pharmacies to contribute to NHS service provision for patients, provide a more rewarding and stimulating working environment for the profession and reduce the burden of work currently carried by GPs.
