## **Statement as per Standing Order 22 (ii)**

### **Purpose**

The purpose of the amendment is to maintain accountability and transparency. Adopted School Organisation Plans are currently sent to the governing body of each school. Regulation 10 of The Education (School Organisation Plans) (Wales) Regulations 2003 will allow local authorities to place a copy of the Internet and notify the governing body of each school. Many parents do not have access to the Internet and it is important that the plan is available to all parents. The best way to do this is for local authorities to continue to send copies of the adopted plan to the governing bodies of each school.

### **Costs**

The current cost of distribution would be retained. There would be no additional costs.
