Payments of Members pay and Allowances

Request for Information.

Thank you for your request received on 10 March in which you asked,

I look for information about way of payments relating travel costs and other MPs' allowances in the EU Member States Parliament. At your web-site I found document named Consolidated Determination on Members pay and Allowances. In Section 2, paragraph 2.3.1 states that salaries are paid directly to the Member's account by electronic transfer. I want to know if this practice is used also for other payments such as allowances. Are there any payments in cash to the Members? Do you know, is such system of payments in place also in other Parliaments in GB?

The National Assembly for Wales is made up of 60 Members, who are elected by the people of Wales to represent them and their communities, make Laws for Wales and to hold the Welsh Government to account. They are referred to as Assembly Members, rather than MP's as you refer to in your request.

Salaries are paid directly into Assembly Members' bank accounts, as are some other types of reimbursement. The other occasions when there will be a direct payment into an Assembly Member's bank account are:

- When the Assembly Member is claiming for reimbursement of petrol costs when they are using their own car for Assembly related travel.
- When they have incurred expenses that are eligible to be reimbursed by the Assembly, but the Assembly Member has paid for them initially themselves. In this case, claims must always be accompanied by appropriate receipts.

There are no payments in cash made to Assembly Members. I cannot comment on practices in other legislatures. You may wish to approach them directly for this information, please see the following links for their contact
