## Gofyn i'r Gweinidog Addysg a Sgiliau To ask the Minister for Education and Skills

William Powell (Canolbarth a Gorllewin Cymru): O gofio bod arweiniad ar reoli asbestos mewn adeiladau parod, a gyhoeddwyd gan yr Awdurdod Gweithredol Iechyd a Diogelwch, yn dweud mai awdurdodau lleol sydd â'r ddyletswydd o reoli asbestos a thalu am ei dynnu o ysgolion ledled Cymru, pa asesiad y mae'r Gweinidog wedi'i wneud o'r posibilrwydd y gallai hyn droi awdurdodau yn erbyn chwilio am asbestos o gofio goblygiadau ariannol y gwaith o'i dynnu.. William Powell (Mid and West Wales): Given that guidance on the management of asbestos in system build premises, published by the Health and Safety Executive, stated that local authorities have the duty to manage asbestos and pay for its removal in schools across Wales, what assessment has the Minister made of the potential for this to act as a disincentive for authorities to search for asbestos given the financial implication of its removal. The Minister for Education and Skills (Leighton Andrews): Locating and dealing with asbestos in schools, including the removal if appropriate is a health and safety matter for schools and local authorities. Local authorities as the building owner and employer have a legal duty under the Control of Asbestos Regulations 2006 to manage the risks arising from asbestos.

The Health and Safety Executive (HSE) do state in their guidance that the most likely way Asbestos Containing Materials will create a risk in schools is when they are damaged through maintenance, repair and construction activities.

Asbestos is safe if undisturbed and schools should work closely with their respective Local Authorities to have in place appropriate health and safety plans for staff, pupils and visitors. Local Authorities are required to have asbestos surveys undertaken on all premises under their control, and implement an asbestos management system. The HSE inspections of local authorities checks for compliance with these requirements.

The Welsh Local Government Association, local authorities and HSE meet regularly and work collaboratively to ensure understanding of the legal requirements and implementation of a risk based approach to the management of asbestos.

Local authorities determine their priorities of investment in the schools estate and then make applications for WG capital grant support as evidenced in the Transitional Schools programme. More specifically, the first wave of programmes approved under the new 21st Century Schools Programme requested that local authorities prioritise those projects where schools were in a poor condition. The degree and nature of asbestos as identified in local authorities asbestos surveys can, and should form a critical part in determining and identifying those schools in poor condition categories. Therefore from both a legal and financial perspective local authorities there should not be a disincentive for them to address the issue of asbestos in schools.

**Leighton Andrews:** Locating and dealing with asbestos in schools (including its removal if appropriate) is a health and safety matter for schools and local authorities.

Local authorities as the building owner and employer have a legal duty under the Control of Asbestos Regulations 2006 to manage the risks arising from asbestos.

Local Authorities should know whether any of their schools contain asbestos in some form or another. Local Authorities are required to have asbestos surveys undertaken on all premises under their control, and implement an asbestos management system. HSE inspections, in Local Authorities, check for compliance of these requirements. With these surveys in place Local Authorities should then factor this information into their programmes of investment for both maintenance and school replacement/refurbishments. It is for Local Authorities to determine their priorities of investment.

The current and projected categories of condition of school buildings were requested, from Local Authorities, as part of the revised proposals submitted to the Welsh Government in November 2011. However, the level of detail, in terms of schools that may have the presence of asbestos was not considered at this stage of the process, since the written statement December 2010 related to overall outline programmes and not individual projects.

The WLGA, LAs and HSE meet regularly and work collaboratively to ensure understanding of the legal requirements and implementation of a risk based approach to the management of asbestos.

Managing asbestos in schools, including removal if appropriate, rests with those responsible for the maintenance of schools, including (in the case of community schools, for example), the relevant Local Education Authority.

HSE guidance in relation to asbestos surveying has been issued with the intention to help both duty holders and surveyors. 'Asbestos - The Survey Guide January 2010' replaces and expands previous guidance issued in 2001.

The Minister for Environment and Sustainable Development (John Griffiths): The Environment Agency were allocated £12.8 million from the Welsh Government for capital funding for flood alleviation works in the financial year 2010/2011 and will receive £10.7 million in 2011/2012. For the financial year 2012/2013 I intend to make £8.9 million available.

Despite the reduction in the capital settlement for the Welsh Government, I have sought to minimise the impacts on the Environment Agency, enabling them to continue their important flood and coastal erosion risk management activities. This includes maximising the benefits from the European Regional Development Fund where appropriate and over the period 2010/11 – 2012/13 the Environment Agency will receive £7.862m from the ERDF.

**Lesley Griffiths:** I refer you to my written statement about the problem of PIP Breast Implants published on 13 January. Costs per patient will vary depending on the clinical complexity of each case and we will have better overall cost information once we have increased clarity on the number of women affected by PIP implants in Wales. Not all the women affected will need or want to have their implants removed or replaced if they are not experiencing problems. My overriding concern is to ensure the health and wellbeing of the women affected and I believe the final costs will be both appropriate and necessary.

I gave a commitment to update Assembly Members as the situation develops.
