The Minister for Environment and Sustainable Development (John Griffiths): The Welsh Government's aim is to secure an appropriate mix of energy provision for Wales, in accordance with sustainable development.

Chapter 12 of Planning Policy Wales (PPW) states that local planning authorities should plan positively for all forms of renewable and low energy development using appropriate and up to date evidence. The definition of renewable energy includes plant material (or biomass) which is continuously and sustainably available in our environment.

Further guidance is contained in Technical Advice Note (TAN) 8: Renewable Energy, which states in relation to Anaerobic Digestion that local planning authority criteria based policies should be supportive, subject to proposals demonstrating appropriate siting and adequate vehicular access.

In October the National Assembly for Wales approved amending relaxing planning application requirements under Parts 6 and 7 of the Town and Country Planning General Permitted Development Order 1995. The amended Order allows the erection, extension, or alteration of a building to house an anaerobic digestion system on agricultural or forestry land without the need to apply for planning permission. These rights apply providing that the fuel or waste is produced solely on the agricultural or forestry land upon which the system serves, and it is not being imported from off the farm or outside the area.

These permitted development rights are consistent with those introduced in England earlier this year.

I want to ensure that any actions to mitigate the problems around sky lantern litter are well designed and based on sound evidence. The Welsh Government is jointly commissioning independent research with Defra to develop an evidence base on the impact of sky lanterns before the end of the year. This research will be completed by the end of March 2013.

Jane Hutt: The Disability Discrimination Act 1995 has been repealed and replaced by the Equality Act 2010. The Equality Act requires service providers to make reasonable adjustments to their premises to remove, alter or provide a means of avoiding features which put disabled people at a substantial disadvantage in comparison with people who are not disabled. The Act does not therefore include any defined measures for compliance in existing buildings, but applies the term reasonable and practicable measures to ensure access for all. I can confirm that the levels of compliance across the Welsh Government's administrative estate are very high, meeting the reasonableness test, with our aim being to provide as far as practicable buildings which provide equal access and functionality for all people. All new property acquisitions, fit out works or alterations to existing buildings are designed to ensure compliance with current legislation and regulations.

Derbyniwyd ateb i'w gyhoeddi ar 03 Rhagfyr 2012 Answer received for publication on 03 December 2012 The Deputy Minister for Children and Social Services (Gwenda Thomas): Existing measures to improve the uptake of Direct Payments are contained within the statutory guidance to local authorities ('Community Care, Services for Carers and Children's Services (Direct Payments) (Wales) Guidance 2011'), which was revised in April 2011 following public consultation.

Regulations which came into force on 11 April 2011 extended Direct Payments to individuals who lack the capacity to consent to them (on appointment of a 'suitable person'), and removed the exclusions which applied to people who were subject to various provisions of the mental health legislation and to the criminal justice relating to mental disorder. This means that all the major groups of social services users are now eligible for Direct Payments if they want them, and also that local authorities have a duty, in most cases, to offer a Direct Payments arrangement.

The guidance stresses the importance of good and accessible information and support in helping individuals decide whether they wish to participate in a Direct Payments arrangement, to know how and where to access services, and to share their experiences of what works and what does not work. All local authorities in Wales have local support schemes to assist Direct Payments users, offering assistance with issues such as recruitment of Personal Assistants and managing the pay roll. These arrangements also include management of Direct Payments on an individual's behalf, where this is what the individual wants.

Making Direct Payments easier for individuals to use, and strengthening the support arrangements available, will be a central feature of the model of citizen-directed support we are seeking to develop through the Social Services and Well-being (Wales) Bill, to be introduced in January 2013.

We will also wish to consider and learn from innovative approaches being undertaken elsewhere. Our overall aim must be to develop a model of citizen-directed support that is right for Wales.

**Assembly Commissioner (Peter Black):** Before 2007, the Assembly leased Tŷ Hywel as a single corporate body consisting of government and legislature and the rent was paid from the overall budget for the Assembly. Since, 2007, the Welsh Government has continued to use offices and facilities at Tŷ Hywel on the basis of a sub leasing arrangement, at a peppercorn rent. No rental or other charges have been sought or paid for the last three years, as the entire budget for the rental and running costs of the building is drawn down from the Welsh Consolidated Fund by the Commission.
