**Andrew RT Davies (South Wales Central):** Will the Minister outline any current or forthcoming Welsh Assembly Government initiatives to stimulate the Aerospace sector in Wales. (WAQ57314)

Andrew RT Davies (South Wales Central): Will the Minister outline any current or forthcoming Welsh Assembly Government initiatives to stimulate the Automotive sector in Wales. (WAQ57315)

Andrew RT Davies (South Wales Central): Will the Minister outline any current or forthcoming Welsh Assembly Government initiatives to stimulate the Electronic sector in Wales. (WAQ57316)

# Answer issued on 31 March 2011

'Economic Renewal: a new direction' explained how our support for business would focus on six key sectors, including ICT and Advanced Materials and Manufacturing (AM&M), in which the aerospace, automotive and electronics sectors would be most visible.

We have ensured that representatives from these sectors are members of the associated Sector Panels tasked with providing policy advice and developing respective sectoral strategies to stimulate economic growth.

Additionally, our anchor companies include a significant presence from these sectors, including GE, Airbus, Ford, Toyota, Sony and PureWafer. The aerospace, automotive and electronics sectors are, therefore, set to benefit from targeted support for business, including repayable finance, support for innovation and R&D, international trade and skills development.

**Nick Bourne (Mid and West Wales):** Will the Minister make a statement on the benefits accrued from the Economic Renewal Programme. (WAQ57317)

# Answer issued on 31 March 2011

Economic Renewal: a new direction is addressing systemic and structural issues within the Welsh economy, as such its full benefits will only be realised over the longer-term. Nevertheless, significant progress is being made in regard to the quality of our infrastructure, skills base, business environment, innovation and business support. These will be summarised in an update that I will make publicly available by the end of this month.

**Nick Bourne** (**Mid and West Wales**): How many staff were initially employed under the Economic Renewal Programme, and how many of these staff remain employed and on what duties and salary. (WAQ57318) *Transferred for answer by the Permanent Secretary* 

#### Answer issued on 05 April 2011

The Permanent Secretary (Dame Gill Morgan): "Economic Renewal: a new direction" (ER) was the most radical change to business support and economic development in Wales in living memory. The project to develop this new policy entailed widespread consultation and engagement with individuals businesses, local authorities, academia, trades unions, other experts and the general public. This major project was delivered within nine months by a team comprising only seven members of staff.

Since the launch of ER and the publication of new organisational structures, the policy and responsibility for implementing it has been mainstreamed across the Department for the Economy and Transport and other Assembly Government Departments. There is currently a team of three members of staff who spend a major part of their time engaged in business continuity and transitional activities related to ER. Although they are engaged in other activities also, it would be difficult to separate out the salary elements for these other activities. The total salary costs for these three staff are £128k per annum. This team will reduce to two in April, reflecting the extent to which the policy has now been embedded throughout the Assembly Government.

**Angela Burns (Carmarthen West and South Pembrokeshire):** Will the Minister outline what steps he has taken to encourage business into wales. (WAQ57319)

# Answer issued on 31 March 2011

We are actively promoting Wales as a business destination through a number of channels at home and overseas. This includes the work of our integrated sector teams, our overseas network and hosting successful major events such as the Ryder Cup which promote Wales, Welsh business and the benefits of doing business in Wales to the world.

In addition we launched a marketing campaign to build upon the momentum of hosting the 2010 Ryder Cup. This campaign has laid the foundations for future marketing activity and its highlight was a successful networking event in London as part of the celebrations surrounding St David's Day. This targeted international business intermediaries in London and the South East.

**Angela Burns (Carmarthen West and South Pembrokeshire):** What assessment has the Minister made of the Welsh Assembly Government's support for Welsh businesses over the past 4 years. (WAQ57320)

# Answer issued on 31 March 2011

We have taken forward a wide range of activity to assess our support for business. Firstly, the Economy and Transport Ministerial Advisory Group considered and reviewed our approach to economic development as part of their independent advice on policy and delivery priorities.

The development of Economic Renewal: a new direction was preceded by a period of extensive dialogue with the business community as well as the public and third sectors. This enabled us to review our approach and assess the challenges and opportunities ahead.

In addition, we have undertaken client reviews on key areas of service delivery. These have included customer satisfaction work on relationship management, our business start-up service, and the regional centre service. Moreover we have recently undertaken a mid-term evaluation of our business start-up service which in common with our other EU funded projects are subject to mid term and end-of-programme evaluations.

**Angela Burns (Carmarthen West and South Pembrokeshire):** What steps is the Minister taking to reduce the impact to commuters of planned works on the M4. (WAQ57321)

#### Answer issued on 31 March 2011

Other than routine maintenance there are no further major works currently programmed beyond the conclusion of the current concrete central reserve barrier works around Newport that are due for completion June 2011. At this time the Variable Speed Limit Scheme (VSL) will operate in its entirety from Junction 24 (Coldra) to 28 (Tredegar Park) and motorists will benefit from the increased journey time reliability that the VSL will bring.

**Angela Burns (Carmarthen West and South Pembrokeshire):** What mechanisms are put in place to retrieve grant funding from businesses who either chose to leave Wales or who close down. (WAQ57328)

# Answer issued on 31 March 2011

In circumstances where it is considered that a company prematurely ceases operations, through closure or relocation, and remains within the period whereby grant conditions remain attached to project support, then the Assembly Government will take all reasonable steps necessary to recover all, or a proportion of the grant provided. The amount recovered will depend upon factors such as; the length of time the project has operated in Wales; whether the project delivered over and above the outputs expected; or where the current economic climate is dictating the action to preserve other parts of the business. The level of recovery is normally adjusted to give credit for jobs and assets which have actually been provided by the project, including any in excess of the required target.

**The Permanent Secretary (Dame Gill Morgan):** For the purposes of this response, I have provided details of full-time equivalent staff, rather than posts, and salary costs as the representative indicator of staff costs. During a period of restructuring, transitional and aspirational posts are created which are either short term or are never filled. Including details of all of these posts would give a misleading picture of staffing levels. The table below therefore details the number of full-time equivalent staff employed on 1 April of each year and the total salaries for DE&T in each of the last three full years.

The total number of full time equivalent staff in DE&T has decreased considerably during the past year, with the total standing at 928.1 on 28 February 2011. This has been largely the result of the development of the Economic Renewal Programme, which has allowed DE&T to review and restructure their workforce to deliver against their revised, focused remit. It is inevitable, however, that staffing levels across all departments within the Assembly Government will continue to decrease over the next 2-3 years as we are forced to live within increasingly tight budget settlements.

**Darren Millar (Clwyd West):** What was the total paid in variable staff pay (i.e. bonuses/performance related pay other than overtime payments) in the Department for Economy and Transport in each year of the Third Assembly. (WAQ57340) *Transferred for answer by the Permanent Secretary* 

#### Answer issued on 25 March 2011

The Permanent Secretary (Dame Gill Morgan): The pay structure for members of the Senior Civil Service (SCS) is managed by the Cabinet Office and overall pay bill increases for members of the SCS are determined each year by HM Treasury and the Cabinet Office. SCS pay is made up of base salary and variable pay and specified proportion of the SCS pay bill is required to be paid in the form of variable pay awards. Variable pay awards are non-consolidated awards paid in addition to any base pay increases. They are paid as a lump sum and do not count towards pension entitlements.

The table below details the variable pay for members of the SCS within DE&T for each of the last three years. The performance of individual members of staff is assessed at the end of each reporting year, with payments for eligible staff usually being made mid-way through the following financial year. Variable pay for 2010-2011 will not, therefore, be awarded until July 2011.

The number of staff receiving variable pay awards in DE&T, and across the wider Assembly Government, decreased substantially for the performance year 2009-10. This was a direct result of the decision of the Welsh Assembly Government's SCS Remuneration Committee to bring forward, by 12 months, the Prime Minister's recommendation to limit performance related pay. The recommendation, that performance related pay would only be awarded to the top 25% of performers, was intended to be introduced for the 2010-2011 performance year. In view of the current economic climate we decided to introduce the change for 2009/10 and also reduce the size of individual awards.

**Angela Burns (Carmarthen West and South Pembrokeshire):** Will the Minister outline what recent discussions he has held and with whom regarding the rag worm farm in Laugharne, Carmarthenshire. (WA57341)

### Answer issued on 31 March 2011

I have not been engaged in any recent discussions concerning the ragworm farm in Laugharne, Carmarthenshire.

**Andrew RT Davies (South Wales Central):** Has the Welsh Assembly Government undertaken any feasibility studies to consider the possibility of building a by-pass around Dinas Powys, and will the Minister publish any such findings. (WAQ57350)

# Answer issued on 31 March 2011

We have not undertaken any feasibility studies for building a bypass around Dinas Powys.

**Andrew RT Davies (South Wales Central):** Will the Minister reveal the total amount of Welsh Assembly Government funding that has been spent by his department on infrastructure in the Vale of Glamorgan, giving figures for the period between 1st April 2005 and 31st March 2010. (WAQ57351)

#### Answer issued on 31 March 2011

A total of £17.1m was spent on the Vale of Glamorgan Railway that opened in summer 2005. We provided a further £7.835m of funding in the form of grants to the Vale of Glamorgan Council for infrastructure projects. I wrote to you on 3 February 2011 enclosing a table of overall expenditure on the St Athan estate that included costs associated with the Aerospace Business Park (ABP), general site development costs and costs in support of the defence technical training project. The total cost for all these areas came to £46.663m.

# To ask the Minister for Environment, Sustainability and Housing

**Andrew RT Davies (South Wales Central):** Was the Environment Agency's 'Life Assessment of Supermarket Carrier Bags' report taken into consideration in the Welsh Assembly Government's decision to introduce a levy on the use of plastic bags by retailers. (WAQ57312)

#### Answer issued on 31 March 2011

The final version of the Environment Agency's report was published in February 2011, after the Single Use Carrier Bags Charge (Wales) Regulations 2010 were made. However, we were aware of the findings of the study prior to publication and they were considered in the development of the carrier bag charge policy and the draft regulations which were consulted on in June 2010. The charge applies to all types of single use carrier bag and does not single out plastic bags.

I welcome the publication of this report. It highlights the fact that whatever type of bag you use, the key to reducing the environmental impact is to re-use it as many times as possible. The charge is not focused only on the use of plastic bags as the charge will apply to all types of single use carrier bags – plastic, paper, degradable plastic and compostable bags.

Whilst the EA report concludes that single use carrier bags have a lower global warming potential than bags that are designed and intended to last longer, the point to remember is that reusable bags are designed and intended to last. The initial upfront use of additional resources to produce reusable bags is more than offset the more times a bag is reused. In fact, the report concludes that the popular plastic 'bag for life' only has to be used four times to ensure that it has a lower carbon footprint than single-use, light-weight carrier bags.

**Angela Burns** (Carmarthen West and South Pembrokeshire): Will the Minister make available all representations made by the Welsh Assembly Government to Electricity Networks Strategy Group since the reconstituted group was formed in 2008. (WAQ57326)

**Angela Burns (Carmarthen West and South Pembrokeshire):** What steps has the Minister taken to unsure Wales' communities were considered as part of Electricity Networks Strategy Group's study 'Our electricity Transmission Network: A Vision for 2020.' (WAQ57343)

**Angela Burns** (Carmarthen West and South Pembrokeshire): What representation has the Welsh Assembly Government made to the National Grid's Undergrounding consultation this year. (WAQ57344)

**Angela Burns (Carmarthen West and South Pembrokeshire):** What assessment has the Welsh Assembly Government made of the potential impact on the Welsh economy and Welsh tourist industry of the plans disclosed in ENSG's 'Our Electricity Transmission Network: A Vision for 2020.' (WAQ57345)

**Angela Burns** (Carmarthen West and South Pembrokeshire): What steps has the Minister taken to ensure that Wales' natural heritage and beauty was considered as part of ENSG's 'Our Electricity Transmission Network: A Vision for 2020.' (WAQ57346)

#### Answer issued on 31 March 2011

The Welsh Assembly Government is a member of ENSG and provides a Welsh perspective. ENSG proposals are based on ensuring, at a strategic level, that new grid capacity in the UK is provided for new low carbon electricity generation as efficiently as possible and with proper consideration of environmental consequences. Officials also attended two recent workshops on undergrounding principles and represented Welsh interests. Officials meet with National Grid and electricity distribution operators regularly. We work closely with these organisations and the regulator Ofgem, to ensure that option appraisals for new grid connections include consideration of connections which might run underground to minimise visual impacts on sensitive landscapes .The consent processes for each major new grid line project are currently a matter for the Infrastructure Planning Commission.

# To ask the Minister for Health and Social Services

**Alun Cairns (South Wales West):** Will the Minister make a statement – giving a breakdown of costs – on how additional funding for wheelchair services in Wales has been spent. (WAQ57310)

#### Answer issued on 25 March 2011

I announced in February an additional £2.2m for wheelchair services across Wales. This investment will aid reduction of waiting times for wheelchair services, particularly for children and young people. The funding will primarily increase clinical staff to improve assessment times, together with improvements in delivery following that clinical assessment.

**Andrew RT Davies (South Wales Central):** Will the Minister issue the Welsh Assembly Government's response to the Health, Wellbeing and Local Government Committee's report into veterans suffering from PTSD. (WAQ57311)

### Answer issued on 25 March 2011

The response was sent to the Chair of the Health, Wellbeing and Local Government Committee on 11 March and formally laid before the National Assembly for Wales on 23 March

**Andrew RT Davies** (**South Wales Central**): Will the Minister circulate the Task and Finish Group's initial findings on NHS Pharmaceutical Services Regulations to Assembly Members for their consideration. (WAQ57313)

# Answer issued on 25 March 2011

Task and Finish Group's 'Emerging Themes' report recommend a holistic review of the process of pharmacy applications, decisions and appeals in order to develop a more planned approach to the provision of these essential services across Wales. The report is in the public domain.

Angela Burns (Carmarthen West and South Pembrokeshire): What steps is the Minister taking to reduce Dental and Orthodontic waiting times in Carmarthen West and South Pembrokeshire. (WAQ57322)

#### Answer issued on 25 March 2011

Hywel Dda Local Health Board (LHB) area has seen significant growth in access to NHS dental services since 2006 with over 40,000 additional NHS patients regularly receiving NHS care. In some LHB areas there are areas where access to NHS dentistry is difficult. We want to see further progress toward reaching a position where everyone in Wales who wants access to NHS dental care will be able to get it.

I also established an expert group to report on the provision of orthodontic services in Wales. The Health, Wellbeing and Local Government Committee have also recently reported on their inquiry into orthodontic services in Wales. Both reports contained recommendations for consideration by the Welsh Assembly Government, LHBs and the dental profession. Recommendations include the development of Managed Clinical Networks to help improve efficiency and effectiveness including the management of those patients waiting for treatment. Other recommendations include work around service development, changes to legislation, along with better referral and monitoring. I am establishing an implementation process to consider the recommendations of both the expert group and the Committee.

**Angela Burns (Carmarthen West and South Pembrokeshire):** What steps is the Minister taking to review the recruitment process in the NHS to ensure that staff are not put under unnecessary pressure when there are vacant posts. (WAQ57323)

### Answer issued on 25 March 2011

Health Boards and Trusts are responsible for ensuring the health and wellbeing of their staff together with safe staffing levels.

There is a standardised recruitment process across NHS Wales designed to support efficient recruitment.

LHBs and Trusts review staffing levels on a regular basis, and when determining whether or not or how to recruit to vacancies, consideration is given to skill mix, patient and staff safety and workload issues.

**Angela Burns** (Carmarthen West and South Pembrokeshire): Will the Minister make a statement regarding the future of Whitybush Hospital. (WAQ57324)

**Angela Burns** (Carmarthen West and South Pembrokeshire): What steps is the Minister taking to ensure the retention of all services offered at Whitybush Hospital. (WAQ57325)

#### Answer issued on 25 March 2011

I have expressed my strong commitment to the future of Withybush Hospital which will continue to be a major provider of modern healthcare in the three counties. Hywel Dda Local Health Board (LHB) is responsible for the management of Withybush Hospital and decisions about how and where services are provided. The LHB has itself provided assurances about the future of Withybush Hospital and is currently working closely with its clinical teams to consider the optimum configuration of services for the population of Hywel Dda.

Existing and planned capital funding at Withybush Hospital, currently more than £19m, should illustrate that the future of Withybush is secure.

**Angela Burns** (Carmarthen West and South Pembrokeshire): Will the Minister make a statement regarding the current waiting times for orthodontic treatment in Pembrokeshire detailing how many people are waiting. (WAQ57327)

**Angela Burns** (Carmarthen West and South Pembrokeshire): Will the Minister make a statement regarding the current waiting times for orthodontic treatment in Carmarthenshire detailing how many people are waiting. (WAQ57329)

#### Answer issued on 25 March 2011

Primary care orthodontics is not included in the targets set out in the Waiting Times Directive. As a result, figures for those waiting for treatment are not held centrally.

Published Referral to Treatment Times (RTT) statistics for January 2011 show 1,466 patients in Wales were waiting for an initial outpatient appointment for orthodontics in hospital provider settings at the end of January, including 4 waiting over 26 weeks. These figures include 91 patients from Hywel Dda Local Health Board (LHB) waiting for orthodontics in a hospital provider setting, 90 of whom were waiting at Abertawe Bro Morgannwg University LHB and 1 at Powys LHB. None of them were waiting over 26 weeks.

In 2009, Pembrokeshire, Carmarthenshire and Ceredigion LHBs signed off plans for the secondary care orthodontic service to be provided in Abertawe Bro Morgannwg University Health Board (ABM ULHB). For technical reasons, figures for the Pembrokeshire area have not been available for inclusion in the statistical data from Hywel Dda LHB from September 2010 to January 2011.

**Andrew RT Davies (South Wales Central):** Will the Minister outline what action is being taken to improve hygiene standards in public buildings, especially hospitals, schools and care homes. (WAQ57347)

# Answer issued on 25 March 2011

The Food Standards Agency (FSA) launched a Food Hygiene Rating Scheme in October 2010. The scheme applies equally to catering facilities in hospitals, care homes and schools and colleges where people might not be able to choose where they eat. Local authorities are the appropriate bodies to take action on improvements required under food safety legislation and this is overseen by the FSA. The First Minister commissioned a review of food law enforcement in Wales from the FSA and a final report is expected at the end of May 2011.

**Andrew RT Davies (South Wales Central):** Will the Minister confirm if there are any plans to introduce a test for HPV in the Welsh Screening Programme for cervical cancer. (WAQ57349)

#### Answer issued on 25 March 2011

We know the Human papillomavirus (HPV) can lead to cervical cancer and that is why we have introduced the vaccine for girls. This protects them against up to 70 per cent of the viruses that can cause cervical cancer. It is important that women continue to attend their cervical cancer screening when they receive their invitation.

The use of HPV testing as part of the screening programme itself is currently being evaluated. Findings have so far been positive. Screening services available in Wales - as in the rest of the UK - are based on expert advice from the National Screening Committee (NSC). The recommendations from the NSC on these developments will be considered by the Welsh Assembly Government.

**Andrew RT Davies (South Wales Central):** Will the Minister reveal the total amount of Welsh Assembly Government funding that has been spent by his department on infrastructure in the Vale of Glamorgan, giving figures for the period between 1st April 2005 and 31st March 2010. (WAQ57353)

#### Answer issued on 25 March 2011

During this period the Assembly Government has invested the following in infrastructure developments in the Vale of Glamorgan:

£26.048 million on a Mental Health Unit for Older People at Llandough (the total expected cost of the scheme is £57.5 million.)

£200,000 on a stroke rehabilitation Centre at Llandough (the total expected cost of the scheme is £5.8 million.)

Four new Primary Care Centres have opened, built by developers. When operational, the Assembly Government will reimburse the recurrent revenue costs over a 20 year period or as long as general medical services continue to be provided from the facility.

The Assembly Government has approved funding for four grants to improve GP premises. The total cost of these works is £14,470 with the Assembly Government contributing £9,604.

The Assembly Government has also allocated discretionary funding of £53 million to Cardiff and Vale University LHB (formerly Cardiff and Vale NHS Trust) during this period. The Assembly Government does not collate details of how this was spent.

**Andrew RT Davies (South Wales Central):** Will the Minister outline the progress of the delivery of a national lip reading strategy for Wales. (WAQ57348)

#### Answer issued on 31 March 2011

As a result of a request for the development of a lip reading strategy, Welsh Assembly Government officials provided an initial scoping paper to the Disability Equality Advisory Group in November 2010. The scoping paper looked at the issue of lip reading in the wider context of communication aids and considered the range of services being provided across all Welsh Assembly Government Departments. At the meeting it was agreed that further work was required.

# Assembly Commissioner for the Sustainable Assembly, Lorraine Barrett AM:

Following the discovery of Plaid Cymru reverse graffiti outside Tŷ Hywel, Commission staff checked the remainder of the estate to ascertain if any other similar graffiti was present. A total of four instances of graffiti were found, all in the same vicinity. These were subsequently removed by the maintenance team. Commission staff have written to the Chief Executive of Plaid Cymru indicating that party political logos cannot be displayed on or near the Assembly estate in this way.

**Nick Bourne (Mid and West Wales)**: How much did the National Assembly for Wales spend in March 2011 removing Plaid Cymru slogans from outside Ty Hywel. (WAQ57331)
