The Minister for Housing, Regeneration and Heritage (Huw Lewis): The Welsh Government provides funding of £200,000 during the current financial year, through the Welsh Books Council, to Golwg 360.

There is no doubt that Golwg 360 has developed significantly since it was established. The number of visits to the website has increased regularly with approximately 90,000 visits a month. It has also contributed to the Welsh Government's aspiration of seeing plurality of news services in Wales.

The investment in Golwg 360 has led to job creation and training in both Golwg Newydd (the company which owns Golwg 360) and its sister company Golwg Cyf., which owns the print magazine. A total of seven posts have been created in Golwg 360, four of them journalist posts, and Golwg itself has created 1.7 new posts. The journalist training has been mostly done in-house taking advantage of the experience acquired by Golwg over many years. The majority of the jobs created are located in the Lampeter or Caernarfon areas.

Janet Finch-Saunders (**Aberconwy**): Will the Minister provide figures for Wales of the total number of empty dwellings, and within this total provide figures for (a) the number of public sector owned empty dwellings; (b) the number of privately owned empty dwellings; (c) the number of public sector owned dwellings empty for more than 6 months; and (d) the number of private sector owned dwellings empty for more than 6 month. Huw Lewis: Based on the most recent information there were 3,585 empty public sector owned housing units at 31 March 2011 of which 1,030 had been empty for more than 6 months.

At 1 April 2010 there were 21,970 private sector dwellings that had been empty for more than 6 months. The private sector figures only include dwellings that have been empty for more than 6 months. We exclude properties that have been empty for less than 6 months from the data collection as these are often empty for legitimate transitional purposes.

You may be interested to know that the data collection exercise showed that of the 21,970 private sector properties that had been empty for more than 6 months at 1 April 2010, 954 (4 per cent) were brought back into use through direct action by local authorities during the 2010-11 financial year..
