Add at the end of the motion "and directs the Executive to produce appropriate rural economic and quality of life indicators that will allow decisions to be taken in order to reverse the decline in the rural economy and rural services."

Minority Part Debate: The Liberal Democrat Party

This Assembly notes:

- That many people, particularly the elderly, remain in hospitals in Wales even when well enough to be discharged and are therefore denied the opportunity to be cared for in the most appropriate environment
- That there are approximately 600 such "blocked" NHS beds in Wales at any one time
- That keeping people in these "blocked beds" is costing the NHS in Wales an estimated £1.3 million pounds a week
- That by freeing up these "blocked beds", there would be scope for an additional 20,000 people to be admitted each year to Welsh hospitals enabling waiting times to be reduced

This Assembly resolves:

- To ensure that all patients are able to receive care in the most appropriate setting
- To ensure that funding is better directed towards tackling the problem of "bed blocking" by making additional resources directly available to Local Health Groups for commissioning appropriate services from health and social service providers
- To promote joint strategies between health authorities, social service departments and the voluntary sector to deal specifically with the problem of "bed blocking"
- To mandate the Assembly Secretary for Health & Social Services, in conjunction with Health & Social Services Committee, to draw up an action plan within three months to tackle "bed blocking" in Wales.

Amendment 1 - Andrew Davies (Swansea West);

Amendment 2 - Dai Lloyd (South Wales West); Add at end of bullet point 7:

',and to urge the Cabinet to give consideration to using some of the additional resources allocated to Health to resource those joint strategies.'

Amendment 3 - Dai Lloyd (South Wales West);

Delete full stop at end of bullet point 8 and add ',with a view to eradicating the problem completely by 2003.'

Amendment 4 - Dai Lloyd (South Wales West);

Add new bullet point at the end:

'That the Health and Social Services Committee consider a long term strategy to increase NHS beds, staff recruitment and retention.'

Amendment 5 - Andrew Davies (Swansea West);

After "This Assembly resolves" delete the second, third and fourth bullet points and replace with:

To promote joint working between health authorities, social services departments, the voluntary and independent sectors to develop a whole-systems approach to the prevention of avoidable hospital admissions, rapid effective treatment, and timely discharge to the most appropriate setting with the right level and mix of support.

To request the Health and Social Services Secretary, in conjunction with the Health and Social Services Committee, to produce within three months a comprehensive plan which deals with these issues.
