The First Minister (Carwyn Jones): On 29 September 2010, the Welsh Government launched Wales' first Major Events Strategy – '*Event Wales*' which aims to build on the success of 'Team Wales' in delivering major international events such as the 2010 Ryder Cup and the 2009 Ashes Test.

The Major Events Unit (MEU) is responsible for leading and co-ordinating the delivery of *Event Wales*. The MEU has made good progress in implementing *Event Wales* and has recorded some early achievements in building Wales' position as an outstanding destination for major events. Highlights include:

Hosting the inaugural International Events Conference at the Royal Welsh College of Music and Drama in November 2011. The conference was attended by a number of key international events industry figures who praised the content, presentation and organisation of the event;

In 2012, with support from the MEU, Wales will host the ICF Canoe Slalom World Cup and Olympic football at the Millennium Stadium:

In 2013, with support from the MEU, Wales will co-host (with England) the Rugby League World Cup – a key element of the UK's Decade of Sport. We will also be hosting WOMEX, the world's leading annual showcase, conference and trade fair for world music;

In 2014, with support from the MEU, another historic milestone for Wales – the Senior Open Championship will be staged at Royal Porthcawl Golf Club. The first time Wales has staged one of golf's 'Majors';

In 2015, with support from the MEU, Glamorgan Cricket will build its position among the world's leading international cricket venues by hosting another Ashes Test Match.

MEU officials are in regular discussions with a range of Welsh, GB/UK and international governing bodies of sport and cultural organisations to identify major event opportunities for 2012/13 and beyond.

Our forth coming Water Strategy consultation will consider issues around the management of our water resources. We will also be working closely with Environment Agency, water companies and other water stakeholders through the Welsh Government Water Industry Forum to ensure a long term approach is adopted for water management in Wales.

Andrew RT Davies (South Wales Central): Has the Welsh rail franchise now reverted back to the flex system, in which individual fares can be increased by more than RPI+1% so long as the annual average rise falls below this mount. (WAQ59671)

Carl Sargeant: In 2011, the policy for the Wales and Borders franchise reverted back to a flexible approach, where individual regulated fares can be increased by more than RPI+1% as long as the average increase across all regulated fares is no more than RPI+1%. This policy is continuing in Wales during 2012, and it is consistent with the policy of the UK Government for regulated fares in England.
