The first 6 questions were reached.

# 2.33pm Points of Order:

1. Christine Humphreys under SO7.2 raised a point of order on use of discriminatory language in the Chamber.

The Presiding Officer drew Members' attention to Standing Order 7.2 and the Protocol on Conduct in the Chamber. He felt that the comments made last week detracted from the dignity of the Assembly and asked Members to be careful in their use of language in the Chamber.

2. Gareth Jones raised a point of order on Standing Order 9 regarding the status of members of subject committees.

The Presiding Officer reminded members that the Assembly had delegated executive functions to the First Secretary and that in turn he had delegated functions to Assembly Secretaries. Thus Assembly Secretaries have an executive responsibility which is different from other members of a committee. The Presiding Officer considered that the First Secretary and his Cabinet were aware of the balance to be struck as between the Cabinet and Committees. He had received a letter from Jonathon Morgan on the same issue and would publish his response to that letter in due course.

3. David Davies raised a point of order concerning the fact that a letter written to the Secretary for Local Government and the Environment had been responded to by the First Secretary.

The First Secretary said that he had replied because the matter had been raised with him personally at a meeting.

4. Peter Black raised a Point of Order (SO6.11) on the Local Government Finance settlement - why it had been presented as a written statement rather than as an oral statement to a plenary session.

The Secretary for the Environment and Local Government said that this was a preliminary draft statement. The Presiding Officer drew attention to SO19.2 and confirmed that the order would be brought to the Assembly for debate in February. He thought that Members might wish to review the operation of SO19 in due course.

5. Jenny Randerson raised a point of order to request a correction to the Record of Proceedings on 24<sup>th</sup> November, where her vote on the second amendment on the motion on Sport in Wales was recorded incorrectly as "against" when she had voted for the amendment.

The Presiding Officer confirmed that the correction would be made - but asked that corrections should be brought to the attention of the editor of the record in the first instance - rather than as a point of order.

6. William Graham raised a point of order on the number of questions reached during First Secretary's question time and drew attention to the length of both questions and answers.
