The National Assembly for Wales:

- 1. Notes the work of the Welsh Assembly Government in eradicating fuel poverty and welcomes:
- a) That £86.5m has been spent on the Home Energy Efficiency Scheme since 2007 and that investment in fuel poverty programmes has been protected even in this tight budget settlement,
- b) The introduction of the new all Wales Fuel Poverty Programme from 1 April, which has been designed to provide advice or install energy efficiency measures to approximately 15,000 households per year, including hard to treat and off-gas grid properties,
- c) The commitment to develop better and more frequent reporting of fuel poverty data,
- d) Investment in wider energy efficiency advice and support through the Energy Saving Trust and Carbon Trust and active engagement with the development of the UK Government's Green Deal,
- e)The 28 arbed projects currently being delivered across Wales' Regeneration Areas, benefiting over 6,000 households, that the £30m invested in arbed by the Welsh Assembly Government has attracted significant additional funding from other sources and that plans to introduce arbed phase 2 in 2011/12 are progressing well.
