The Health and Social Services Committee of 16th March decided to extend free eye tests to ethnic minorities, hearing impaired people, unioocular people and those at risk from retinitis pigmentosa as these groups are at higher risk of eye disease. This decision was reaffirmed in the Health and Social Services Committee on 7th June.

*Mae Cynulliad Cenedlaethol Cymru yn croesawu'r ffaith bod Cymdeithas Alzheimer wedi cyhoeddi'r adroddiad : 'Food for Thought' sy'n crynhoi pryderon bron 4000 o ofalwyr pobl sy'n dioddef gan ddementia, a phryderon gweithwyr proffesiynol mewn perthynas â bwyd a bwyta. Mae'n galw ar yr awdurdodau statudol yng Nghymru i edrych ar y sefyllfa yn eu hardaloedd hwy a gweithredu'r argymhellion sydd yn yr adroddiad, gan gynnwys darparu:
? Cymorth a chyngor ar fwyd a bwyta ar gyfer pobl sy'n dioddef gan ddementia ac ar gyfer gofalwyr sy'n byw gartref;
? Bwyd o ansawdd da, a dewis o fwyd mewn cartrefi gofal ac ysbytai;
? Hyfforddiant ar gyfer gweithwyr gofal proffesiynol ar sut y gall dementia effeithio ar fwyta.*

The National Assembly for Wales welcomes the publication by the Alzheimer's Society of the report 'Food for Thought' summarising the concerns of almost 4000 carers of people with dementia and professionals in relation to food and eating. It calls on statutory authorities in Wales to examine the position in their areas and to implement the recommendations contained in the report, including providing:

*? Help and advice on food and eating for people with dementia and carers living at home;
? Good quality food and choice of food in care homes and hospitals;
? Training for care professionals on how dementia can effect eating.*

Cynnig bod Cynulliad Cenedlaethol Cymru yn arfer ei bwerau i wneud gorchymyn cychwyn sy'n dod â Rhan IIA o Ddeddf Diogelu'r Amgylchedd 1990 i rym, sy'n cynnwys mesurau y byddai'n ei gwneud yn ofynnol i adfer tir halogedig sy'n anharddu Cymru. Byddai'n strategaeth gynhwysfawr ar gyfer nodi, asesu ac adfer tir sydd wedi'i halogi yn y gorffennol, megis tir Phurnacite gynt yng Nghwm Cynon, ac yn aseini rhwymedigaethau ar y sail mai'r "llygrwr sy'n talu". Mae gan y Cynulliad ddyletswydd i sicrhau bod y gorchymyn cychwyn hwn yn cael ei ddeddfu fel mater o flaenoriaeth er mwyn rhyddhau tir at ddibenion datblygu diwydiannol, tai a hamdden.

That the National Assembly for Wales exercises its power to make a commencement order bringing into force Part IIA of the Environmental Protection Act 1990 which contains measures that would require remediation of contaminated land which blights Wales. It would provide a coherent strategy for identifying, assessing and remediating historically contaminated land such as the former Phurnacite land in Cynon Valley and assigning liabilities on the basis of the "polluter pays" principle. The Assembly has a duty to ensure that this commencement order is enacted as a priority, to enable the release of land for industrial development, housing and leisure.
