Dear Llyr,

I am writing to clarify comments I made in responding to questions you asked at the Oral Questions session in the Siambr on 26 April 2023. When responding to your question on access to dentists for children, I said:

26/04/2023 15:06:36 paragraph 131 – "Evidently, we're in negotiations for the next contract, and it is difficult because what we see is that some dentists are leaving the NHS and going private. Well, they are individuals; they don't work directly for the NHS—dentists have never worked directly for the NHS—and so, we can only go as far as we can afford to go to pay these people to work in our system".

On reflection, what I said could be interpreted to be referring to <u>all</u> dentists and that the move to private is financially driven which is not what I intended. Many dentists work in hospital and community dental services and are directly employed by the NHS. My comment was intended to refer to high street or, to use the proper terminology, those dental practices with an NHS contract to provide general dental services (GDS).

The point that I was trying to make was to acknowledge that there has been some movement this year by GDS contract holders towards private only care and that as independent contractors who are not employed directly by the NHS, this is a choice they are free to make based on their own circumstances. An NHS contract has many benefits for the dentist such as: guaranteed patient demand, a reliable revenue, pension and maternity leave. However, some dentists feel that providing a service to private patients only gives them flexibility to provide a wider range of dental services that are financially more advantageous and/or require them to see fewer patients. Ultimately, it is difficult in an age of financial constraint for the NHS to offer more or equivalent money compared to what a dentist can earn privately.
