Dear Members of the Senedd,

As you will be aware phase 3 of the Economic Resilience Fund (ERF) opened for applications yesterday. Phase 3 of the ERF makes available almost £300m for businesses to help them deal with the economic challenges of Covid-19 and the UK's impending exit from the EU transition period.

This enhanced, third phase of the ERF provides Business Development Grants to help businesses sustain and prepare themselves for the longer term, including ring-fenced support for tourism and hospitality businesses. The package also provides support, linked to the non-domestic rates (NDR) system, for businesses directly affected by the firebreak as well as those subject to local restrictions previously in place in some areas. In addition there is a Lockdown Discretionary Grant for businesses.

The demand for the Business Development Grants has been exceptional, and at the point of writing, over 5,000 applications have been received. Consequently, from 6pm this evening, the fund will be paused to allow an assessment of applications made against fund value.

Please also note that while some businesses will have properties that are automatically eligible for an NDR grant, to receive any of the Lockdown Business Grants, businesses will need to register their details, as well as make a short on-line application to their respective local authority for the discretionary elements.
