**The Minister for Education and Skills (Huw Lewis):** The Further and Higher Education White Paper published in May 2012 indicated that the Welsh Government would allow time for higher education reconfiguration to progress and for the new funding arrangements to embed, before looking afresh at governance arrangements in the HE sector.

Earlier this year, we consulted on proposals for a new regulatory framework for higher education in Wales which include revised arrangements for financial and governance assurance. In due course, I intend to bring forward legislation that will place HEFCW under a statutory duty to prepare and publish a Financial and Corporate Governance Code of Practice. All institutions with an approved fee plan in Wales will be required to comply with the Code of Practice.
