

## **Motions and Amendments for Debate on 13 January 2004**

### **Motions tabled on 6 January 2004**

#### **NDM1761 Karen Sinclair (Clwyd South)**

To propose that the National Assembly for Wales:

Considers the principle of The Welsh Language Schemes (Public Bodies) Order 2004 a copy of which was laid in Table Office on 25 November 2003

#### **NDM1762 Karen Sinclair (Clwyd South)**

To propose that the National Assembly for Wales:

1. Considers the report of the Legislation Committee laid in the Table Office on 2 December 2003 in relation to the draft order The Welsh Language Schemes (Public Bodies) Order 2004 and

2. Approves that The Welsh Language Schemes (Public Bodies) Order 2004 is made in accordance with the draft order laid in the Table Office on 25 November 2003 and the Regulatory Appraisal laid in the Table Office on 26 November 2003.

2. Consider the Minister for Finance, Local Government and Public Services' letter of 1 December reporting the UK Government's response to the Public Audit (Wales) Bill Committee's recommendations on the draft Public Audit (Wales) Bill;
3. Report to the Assembly by 6 February on its conclusions.

The Committee shall cease to exist on 27 February 2004.
