Debate on Revising and Remaking the Sustainable Development Scheme

NDM1866 Karen Sinclair (Clwyd South)

To propose that the National Assembly for Wales

- 1. Adopts as its Sustainable Development Scheme, in accordance with Section 121(1) of the Government of Wales Act 1998, the document entitled 'Starting to Live Differently' which was emailed to Assembly Members on 9 March 2004.
- 2. Notes that a draft Action Plan to enable the Welsh Assembly Government to implement the Scheme is being prepared and will issue for consultation shortly.
- 3. Notes the commitment to finalise a set of top-level composite indicators to gauge progress towards sustainable development.

- 4. Commends the positive role that Wales is taking in international thinking on these issues and in particular the progress of the international regional government network, whose conference takes place in Wales from 22-26 March.
- 5. Thanks all individuals and organisations who responded to the consultation.

but regrets the inadequacy of paragraph 1.4 of the Scheme which describes the current unsustainability of Wales and calls on the Minister to re - draft the paragraph in consultation with appropriate voluntary organisations'.

In point 2 delete 'and will issue for consultation shortly' and replace with 'and will be issued for consultation before 1st April 2004'.

NDM1870 Jocelyn Davies (South Wales East)

The National Assembly for Wales:

- 1. Believes that affordable housing is a human right.
- 2. Calls on the Labour Assembly Government to introduce measures to ensure that all people have access to quality affordable housing within their own community.

The following amendments were tabled:

Amendment 1 - Karen Sinclair (Clwyd South)

Delete all after 'The National Assembly for Wales:' and replace with:

Reaffirms the vision set out in "Better Homes for People in Wales" - that everyone should have the opportunity to live in good quality, affordable, housing; to be able to choose where they live and decide whether buying or renting is best for them and their families; and

2. Supports the action, which the Welsh Assembly Government has taken to create opportunities for people to access affordable housing.

Amendment 2 - Kirsty Williams (Brecon and Radnorshire)

Add new point at the end of the motion:

Recognises that although the Homebuy scheme has made a significant contribution to providing affordable housing in rural areas, it has done so by eating into the money available to build new homes for rent. Accordingly, this Assembly calls on the Government to establish a separate Homebuy budget line in addition to the existing resources available for Social Housing Grant.

Amendment 3 - Kirsty Williams (Brecon and Radnorshire)

Add new point at the end of the motion:

Recognises the high level of disrepair in privately rented accommodation in Wales and urges the Welsh Assembly Government to work in partnership with UK Ministers to put a compulsory private rented housing licensing scheme in place at the earliest possible moment to establish minimum standards and better management.

Amendment 4 - Kirsty Williams (Brecon and Radnorshire)

Add new point at the end of the motion:

Recognises that although affordability is a key factor so is fitness for purpose. Further recognises that many privately owned properties in Wales will fail to reach the Welsh Housing Quality Standard by 2010 and urges the Welsh Assembly Government to increase the resources available for Disabled Improvement Grants and Renovation Grants whilst developing other forms of investment such as equity release through a Welsh Home Improvement Lending Agency.

Amendment 5 - Kirsty Williams (Brecon and Radnorshire)

Add new point at the end of the motion:

Calls on the Welsh Assembly Government to require Councils to take account of affordability in drawing up Local Housing Strategies and use their powers to ensure that these strategies are delivered on time and are relevant and fit for purpose.

Amendment 6 - Kirsty Williams (Brecon and Radnorshire)

Add new point at the end of the motion:

Expresses concern at the impact of proposals by the Treasury to allow tax relief on the purchase of residential property as a private pension investment, recognises that this will have an impact on the affordability of houses in rural areas and urges the Welsh Assembly Government to oppose this measure.

Amendment 7 - Kirsty Williams (Brecon and Radnorshire)

Add new point at the end of the motion:

Calls on the Assembly Government to support and encourage local planning authorities in engendering greater flexibility for different affordable housing planning policies to be developed. In particular calls for the use of exceptions policies to provide affordable housing in rural areas.

Amendment 8 - Kirsty Williams (Brecon and Radnorshire)

Add new point at the end of the motion:

Requires the Welsh Assembly Government to ensure that all local authorities carry out local housing needs surveys and recognises the need for Planning Authorities to undertake surveys on a community level in order to establish local housing needs.

Amendment 9 - Kirsty Williams (Brecon and Radnorshire)

Add new point at the end of the motion:

Calls on the Welsh Assembly Government to encourage and promote the formation of Community Housing Trusts.

Amendment 10 - Kirsty Williams (Brecon and Radnorshire)

Add new point at the end of the motion:

Recognises that affordability also encompasses costs such as those for energy and calls on the Welsh Assembly Government to promote sustainable principles in the development of new Social Housing.
