

# The Commission for Tertiary Education and Research Transfer (No. 1) (Wales) Scheme 2024

The Welsh Ministers, in exercise of the powers conferred by section 24 of and Schedule 2 to the Tertiary Education and Research (Wales) Act 2022<sup>(1)</sup> (“the Act”), make the following Transfer Scheme. A copy of this Transfer Scheme has been laid before Senedd Cymru in accordance with paragraph 3 of Schedule 2 to the Act.

## **Title and commencement**

**1.**—(1) The title of this Scheme is the Commission for Tertiary Education and Research Transfer (No. 1) (Wales) Scheme 2024 (“this Scheme”).

(2) This Scheme comes into force on 1 August 2024.

## **Interpretation**

**2.** In this Scheme—

“civil service” (“*gwasanaeth sifil*”) means the civil service of the State;

“collective agreement” (“*cydgytundeb*”) and “collective bargaining” (“*cydfargeinio*”) have the same meanings as in section 178 of the Trade Union and Labour Relations (Consolidation) Act 1992<sup>(2)</sup>;

“the Commission” (“*y Comisiwn*”) means the Commission for Tertiary Education and Research;

“grant agreements” (“*cytundebau grant*”) includes “grant funding agreements” (“*cytundebau cyllid grant*”) and “funding agreements” (“*cytundebau cyllid*”) transferring from the Higher Education Funding Council for Wales and the Welsh Government to the Commission for Tertiary Education and Research;

“HEFCW” (“*CCAUC*”) means the Higher Education Funding Council for Wales;

“members of staff” (“*aelodau o staff*”) means the members of staff transferring from HEFCW and

the Welsh Government under article 3 of this Scheme;

“records” (“*cofnodion*”) include written records and records conveying information by any other means.

**Transfer of members of staff from HEFCW and the Welsh Government to the Commission and continuity of employment**

3. On 1 August 2024, the members of staff whose HEFCW and Welsh Government staff numbers are listed in Part 1 of the Schedule transfer to the employment of the Commission.

4. Subject to article 5, on 1 August 2024, the following are transferred to the Commission—

- (a) all staff who had been employed until that time by HEFCW or the Welsh Government and whose staff numbers are listed in Part 1 of the Schedule,
- (b) all employment records held by HEFCW or the Welsh Government in relation to staff transferred by article 4(a),
- (c) all rights, powers, duties and liabilities under or in connection with the contracts of employment of the staff transferred by article 4(a), and
- (d) ICT peripherals, computer mice, keyboards, headsets, monitors, chairs, desks and footrests provided by the Welsh Government to the staff transferred by article 4(a) in relation to homeworking.

5. Article 4 does not—

- (a) transfer or otherwise affect the liability of any person to be prosecuted for, convicted of and sentenced for any offence,
- (b) transfer any rights, powers, duties or liabilities in relation to any provision of a collective agreement if that provision is agreed on or after 1 August 2024 and the Commission was not a participant in the collective bargaining for the provision, or
- (c) transfer laptops, mobile phones and webcams provided to Welsh Government staff by the Welsh Government.

6. The period of continuous employment of the members of staff is not broken by the transfer to the employment of the Commission.

7. The contract of employment of a member of staff transferred by article 4(a) has effect after the transfer as if originally made between the member of staff and the Commission except that it has effect as if it does not

incorporate provisions of a collective agreement as set out in article 5(b).

**8.** Anything done or omitted to be done by the Welsh Ministers or HEFCW before 1 August 2024 in relation to the contracts of employment of the members of staff transferred by article 4(a) is treated on or after 1 August 2024 as having been done or omitted to be done by the Commission.

**Transfer of the contracts, arrangements, schemes, assets, grants, and liabilities of HEFCW to the Commission**

**9.** On 1 August 2024, the following matters will transfer from HEFCW to the Commission—

- (a) the contracts listed in Part 2 of the Schedule, including the right to any associated warranties and the transfer of any associated liabilities;
- (b) all grant agreements issued in writing by HEFCW and the associated rights and liabilities, including grant agreements—
  - (i) still having effect as at 1 August 2024;
  - (ii) concerning funding to be provided and still having effect after 1 August 2024;
- (c) the office assets listed in Part 3 of the Schedule and the associated rights and liabilities;
- (d) the ICT assets listed in Part 4 of the Schedule, including software licences, hardware and website domain names, and the associated rights and liabilities;
- (e) all arrangements concerning outstanding and future pension costs owed to the former chair of the HEFCW council who held the position between March 2002 and February 2008 and the transfer of any associated liabilities, including—
  - (i) all outstanding pension costs owed by HEFCW for the period from 1 April until the 31 July 2024;
  - (ii) all future pension costs from 1 August 2024;
- (f) all outstanding financial liabilities against HEFCW's accounts;
- (g) all cash balances held in HEFCW's accounts.

**10.** Article 9 does not transfer Crown copyright.

### **Transfer of physical and digital records of HEFCW to the Commission**

11. On 1 August 2024, the following matters will transfer from HEFCW to the Commission—

- (a) all physical and digital records, including documents, emails, websites and databases, held by HEFCW at its dissolution,
- (b) all records stored at the HEFCW offsite storage facilities as provided by Restore PLC under contract reference C02HE/2018/19, and
- (c) all records held at the National Archives on behalf of HEFCW.

### **Transfer of contracts and agreements entered into by the Welsh Government on behalf of the Commission and transfer of assets purchased by the Welsh Government on behalf of the Commission**

12. On 1 August 2024, the following matters will transfer from the Welsh Government to the Commission—

- (a) the agreement entered into on the 23 May 2024, with Cardinus Risk Management Limited, for the provision of Health and Safety E-Learning Courses (including DSE) under reference CTER01/04/2024, including the right to any associated warranties and the transfer of any associated liabilities,
- (b) all fixtures and fittings commissioned by the Welsh Government, undertaken by MITIE, and subcontracted to Islwyn Pugh Construction Ltd from 5 February 2024 to 30 April 2024 under Welsh Government contract reference C335/2016/2017, in relation to the refurbishment of the Commission's domain on the 5th floor of 2 Capital Quarter, Tyndall Street, Cardiff CF10 4BZ,
- (c) all fixtures, fittings and furnishing commissioned by the Welsh Government and undertaken by BOF under purchase order 20333029 in relation to the refurbishment of the Commission's domain on the 5th floor of 2 Capital Quarter, Tyndall Street, Cardiff CF10 4BZ,
- (d) all furniture provided by Welsh Government comprising 36 desks, 20 meeting room chairs, 18 monitor arms and 5 cupboards, collected by BOF from Welsh Government Office at Government Buildings, Picton Terrace, Carmarthen SA31 3BT, and delivered to the Commission's domain at 2 Capital Quarter, Tyndall Street, Cardiff CF10 4BZ on 14 March 2024, under invoice 192528, and

- (e) ICT system commissioned by the Welsh Government, on behalf of the Commission, and delivered by SA Global under Welsh Government contract reference C008/2022/2023 and purchase orders 20-31-93-01, 20-32-17-63, 20-32-68-91, and based on Cloud Architecture services provided by Gavin James, via Reed Specialist Recruitment Ltd, under purchase Order 20-33-53-69.

**13.** Article 12 does not transfer Crown copyright.

**14.** In relation to article 9, from 1 August 2024, in all agreements, contracts or legal proceedings which relate to any contracts, schemes, financial systems, grants and liabilities transferred by this Scheme, references to HEFCW will be read as references to the Commission unless the contrary intention applies.

**15.** In relation to article 12(a), from 1 August 2024 all references in the agreement to the Welsh Government and Welsh Ministers will be read as reference to the Commission unless the contrary intention applies.

**Transfer of contracts entered into by HEFCW on behalf of the Commission and transfer of assets purchased by HEFCW on behalf of the Commission**

**16.** On 1 August 2024, the following matters will transfer from HEFCW to the Commission—

- (a) all contracts entered into by HEFCW on behalf of the Commission listed in Part 5 of the Schedule, including the right to any associated warranties and the transfer of any associated liabilities;
- (b) all assets purchased by HEFCW on behalf of the Commission listed in Part 5 of the Schedule, including software licences, hardware and website domain names, and associated rights and liabilities.
- (c) all assets purchased by HEFCW between 17 July and 1 August 2024 under purchase order no. HE7395, HE7405 and HE7406, including software licences, hardware and website domain names, and associated rights and liabilities.

**Trademark licence**

**17.** The trademark licence for the name HEFCW under the trademark registration number UK00003081821 will transfer from HEFCW to the Commission on 1 August 2024.

### **Access to documents and records**

**18.**—(1) Where the Welsh Government hold records or documents which relate to or are connected with the property, rights, and liabilities transferred to the Commission under this Scheme, but which do not transfer, the Welsh Government may provide to the Commission any such record or document on such conditions and subject to such restrictions as the Welsh Government consider appropriate.

(2) Where records and documents have transferred to the Commission under this Scheme, the Welsh Government may, after providing reasonable notice to the Commission, take or be supplied with copies of those records or documents, or any part of them.

### **Modification of this Scheme**

**19.**—(1) The Welsh Ministers may modify this Scheme by agreement with the Commission.

(2) Modifications may have effect from 1 August 2024.
