"acknowledges the long-term objectives as laid out in the Rural Development Plan for Wales 2000-2006, and recognises the importance of a partnership between the Assembly, farmers and their representatives in securing a long-term and sustainable future for the industry in Wales."

Amendment 2 - Jocelyn Davies (South Wales East)

In the first line replace the word 'supports' with 'notes'.

Amendment 3 - William Graham (South Wales East) Peter Rogers (North Wales)

At the end of the motion add:

", which can only be achieved on the basis of a level playing-field for the industry based on a fair deal for farmers."

Amendment 4 - Jocelyn Davies (South Wales East)

Add at end of motion as new bullet point :

Confirms that Agriculture is a basic industry of vital importance to the Welsh Economy and recognises that food production and land use is central to achieving the National Assembly's commitment to Sustainable Development;

Amendment 5 - Jocelyn Davies (South Wales East)

Add at end of motion as new bullet point :

Considers the adoption of alternative indicators, in addition to GDP, to measure the contribution of agriculture to the Welsh Economy;

Amendment 6 - Jocelyn Davies (South Wales East)

Add at end of motion as new bullet point :

Recognises the importance of ensuring that young farmers enter the Agriculture industry and regrets the failure of the Coalition Government of Wales to implement the Committee decision to finance the establishment of a Young Entrants Scheme as one of its main priorities.
