**The First Minister (Carwyn Jones)**: The Millennium Stadium will see the first action of the 2012 Olympic and Paralympic Games – two days before the opening ceremony, when four of the qualifying women's football teams will play a double header of group games. The stadium will host 11 matches on eight dates in both the men's and women's football competitions, starting on Wednesday 25th July and finishing with the men's bronze medal match on 10th August. The stadium company will of course be benefiting directly as a result of its commercial agreement with LOCOG and becoming an Olympic competition venue also adds considerable value to its marketing strategy for attracting future events.

In terms of wider benefits to Wales, the eyes of the world will be on the UK in the summer of 2012 and the Olympic football matches at the Millennium Stadium are an opportunity for Wales to raise its distinctive profile with a range of influential audiences. In addition, significant investment by the London 2012 Organisation Committee (LOCOG) has been made in the infrastructure of the training facilities at Cardiff University's playing fields in Llanrumney, which will be used by teams scheduled to play here. Hosting visiting teams and the 'Olympic family' members and media in attendance will provide a further economic boost. The full extent of the economic impact on Wales will of course be largely contingent upon final ticket sales achieved by LOCOG and those calculations can only be made when the number and profile of visiting fans is known.

The Welsh Government is committed to maximising the opportunities from the London 2012 Olympics and Paralympics by promoting trade and investment, boosting tourism, and enhancing Wales's global reputation leading up to, during and following the Games.

I have no evidence that IPFR panels are convening less frequently or that Health Boards are constraining decisions for financial reasons.

**The Minister for Housing, Regeneration and Heritage (Huw Lewis):** The Welsh Government fully supports the Millennium Stadium as a host venue for the Olympic Games Football Tournament which is a very exciting prospect and hosting such an event will raise the profile of sport across Wales. The football event offers an occasion which I hope will help to inspire young people across Wales to participate in the game and in sport generally. I would like to make clear that the configuration of the Olympic football tournament itself and the constitution of participating teams is a matter for the football authorities concerned and is not a matter for Welsh Government.

High profile sporting events do of course focus public and media interest on sport. It is important to have in place sport programmes which support participation in order that young people in particular have opportunities to become involved in sport. This helps to convert short term interest in sport into long term participation. Sport Wales have in place a number of sport programmes and they will continue to work with key partners to get more people involved in a wide range of sports, help in recruiting more coaches and encourage sports club membership, all of which helps people to lead a more healthy, active lifestyle.
