- The National Assembly for Wales (Social Services Explanations) Regulations 2005

These Regulations will enable the Assembly to require prescribed persons to provide explanations of any documents or information that it has obtained in the exercise of its social services review and investigation functions under the Health and Social Care (Community Health and Standards) Act 2003.

 The Education (Disapplication of the National Curriculum at Key Stage 1) (Wales) Regulations 2005 These Regulations provide for the disapplication of the National Curriculum for Wales for pupils at maintained schools who are in the first Key Stage and who are participating in the Foundation Phase Pilot.

- Motion to approve The Adoption Support Services (Local Authorities (Wales) Regulations 2005

These Regulations will extend the national framework for adoption support services in Wales, that was introduced on 1 October 2004, to specify the services that are to be provided by local authorities as adoption support services and the arrangements for nomination by authorities of a 'key worker' to support adoptive families. They stipulate how the duty to carry out an assessment for adoption support services is to be discharged; the procedure for so doing; the preparation of an adoption support plan where the decision is to provide support services and arrangements to review provision of any adoption support services. Provision is made about recovery of expenses between authorities and as to the circumstances where financial support may be paid to adopters, the process for determining the amount and payment arrangements, reviews of payments and keeping of records. The Regulations revoke the Adoption Allowance Regulations 1991 in relation to Wales, as well as the Adoption Support Services (Local Authorities) (Wales) Regulations 2004.

- Motion to approve The Special Guardianship (Wales) Regulations 2005 These
 Regulations implement in Wales the new legal status of special guardianship, to
 provide permanence for those children for whom adoption is not appropriate and to
 make provision for a range of services to support special guardianship orders. A
 special guardian of a child has sole parental responsibility for the child.
- Motion to approve The Adoption Support Agency (Wales) Regulations 2005

These Regulations will implement that part of the Adoption and Children Act 2002, which makes new provision to regulate independent adoption support providers as 'Adoption Support Agencies' (ASAs) to ensure that services are provided to a high standard and by those suitably qualified and experienced to meet adoption-related needs. It is also the objective that in addition to local authorities and voluntary adoption agencies (VAAs), others wishing to provide birth records counselling to adopted adults will be able to register as ASAs for this specific purpose. ASAs will

also have a role to play in facilitating contact between adopted adults and their birth relatives.

Regulation of the currently unregulated independent adoption support service sector will seek to stop unsuitable or unqualified providers from offering services to those seeking to adopt or affected by adoption, in addition to driving up standards in overall service provision.

Organisations (profit and non-profit making) providing adoption support services as their business or profession will be required to apply for registration as ASAs to the National Assembly for Wales. Some of the main providers of adoption support services such as local authorities and VAAs are exempt from registering as they are already regulated through other means. However, it is the intention that in the future all providers of adoption support services will have to meet similar standards to ensure a coherent and fair system for both service users and providers.
