#### Latest news

#### Science, Technology, Engineering and Mathematics (STEM) Agenda

The Committee took evidence from key stakeholders throughout the autumn term and scrutinised the Minister for Children, Education and Lifelong Learning; and the Deputy Minister for Science, Innovation and Skills at its meeting on 8 December. The Committee will publish its report early in the spring term.

#### **Economic Renewal Programme**

The Committee conducted an inquiry into the Implementation of the Welsh Government's Economic Renewal Programme. The Committee has written to the Minister for Economy and Transport outlining key issues and recommendations to the Welsh Government. We expect the Minister's response to the letter in the spring term. The Committee intends to scrutinise the Minister on his response at a meeting in the spring term.

#### Role of social enterprises in the Welsh economy

The Committee took evidence from key stakeholders within the social enterprise sector in Wales and scrutinised the Minister for Economy and Transport. The report was published on 18 November 2010 at a networking event at Pack-IT's new premises in Cardiff and can be accessed on the following link;

#### Young People Not in Education, Employment or Training

The Committee took evidence from key stakeholders and scrutinised the Minister for Children, Education and Lifelong Learning. The report was published on 15 October 2010 and can be accessed on the following link;

The report and the Minister's response will be debated in Plenary on 12 January 2010.

### Rapporteur Group on Bilingualism

The Committee published its report on the first stage of the inquiry 'The teaching and acquisition of Welsh as a second language' on 30 September 2010. The report and Minister's response were debated in Plenary on 1 December.

The rapporteur group has also taken evidence on the second stage of the inquiry on Bilingual training and skills in the workplace; and business interface with the public.

The group took evidence from the Welsh Language Board and Consumer Focus Wales on 29 September 2010 and visited Natwest and CADCentre UK in Cardiff on 1 December 2010. The rapporteur group will publish its second report in the spring term.

# Committee activity for the spring term 2011:

<u>Please note that information regarding dates and topics of inquiry is subject to change, depending on emerging priorities.</u>

Given that the Assembly will be dissolved on 31 March the Committee has agreed to hold one-off scrutiny sessions in the spring term to

monitor the Welsh Government's progress in implementing recommendations from previous inquiries.

Review of the roads programme in Wales - There will be two sessions in January which will include evidence from stakeholders including the Traffic Commissioner for the Welsh area and the West Midlands area and scrutiny of the Minister for Economy and Transport.

**Review of the rail programme in Wales** - There will be two sessions in January which will include evidence from key stakeholders and scrutiny of the Minister for Economy and Transport.

Review of the handling of the Committee's Proposed (Highways and Transport) Legislative Competence Order – The Committee's Proposed Order 2010 is being progressed. The Deputy First Minister agreed to support the Proposed Order and to facilitate its passage through Whitehall. Negotiations between relevant Welsh Assembly Government officials and Whitehall officials are taking place and the LCO is expected to reach the Welsh Affairs Committee after Christmas.

The Committee has invited the Secretary of State for Wales and the Minister for Economy and Transport to be scrutinised on the process of the LCO at a meeting in February.

Structural Funds – Implementation of the 2007-2013 programmes – There will be two sessions in February to re-visit this inquiry. The Committee will take evidence from key stakeholders and scrutinise the Minister for Economy and Transport.

**Economic Renewal Programme** – As previously highlighted, there will be one session in February to re-visit this inquiry. The Committee will scrutinise the Minister for Economy and Transport.

The Economic contribution of higher education in Wales – There will be one session in March to re-visit this inquiry which will include evidence from key stakeholders. The Committee will follow up on the Government progress in implementing the recommendations in the Committee's report by taking evidence and scrutinising the Minister for Economy and Transport.

**Transformation agenda for post-16 education** – The Committee will scrutinise the Minister for Children, Education and Lifelong Learning on his response to the Committee's letter which was published in summer 2010.

**Skills in Wales** - The Committee will take evidence from key stakeholders and scrutinise the Deputy Minister for Science, Innovation and Skills at a meeting in March.

The impact of the UK Government's Quango policy on Wales - There will be one session in March.

## How we plan inquiries

Ultimately all inquiries begin with the ideas, aspirations, expertise, and knowledge of Assembly Members, who in turn are informed by their constituents and professional contacts.

Usually Members and officials discuss the planning of inquiries every term so that the Committee has a rolling, flexible, programme of work.

Inquiries can arise in a number of ways:

- Frequently, the Committee will decide that it wishes to revisit certain inquiries, after a suitable time has elapsed, to determine whether the Welsh Government is implementing the Committee's recommendations. In these cases, it will carry out a relatively short follow-up inquiry.
- The Petitions Committee may propose that scrutiny committees undertake inquiries and/or investigate in other ways issues raised in petitions. The Enterprise and Learning Committee has reported on a number of petitions – for example, Carno railway station; fuel and road haulage; additional learning needs and the 'Pride in Barry' petition.
- Since Committees can propose legislation, they may undertake pre-legislative scrutiny inquiries to ensure that the legislation as drafted is robust and meets the needs of all stakeholders.
- Where UK legislation has significant implications for Wales, the Committee may undertake scrutiny of UK draft Bills or UK Bills.
- Following an inquiry in a particular area, the Committee may consider that one or two issues arose that it would wish to scrutinise in further detail. For example, the Committee reported in February 2009 on the Teacher Workload Agreement and as a result, Members undertook a further inquiry on the role of school governors.
- The Committee may decide that a particular issue requires a
  more informal and flexible approach than scrutinising evidence
  in formal hearings. It may therefore establish a rapporteur group
  of, say, four members, to undertake work behind the scenes, as
  it were, and then report back to the full Committee. This is what
  happened in the case of the Committee's report on dyslexia. The
  Committee currently has a rapporteur group considering aspects
  of bilingualism.

• Sometimes stakeholders suggest to the Committee directly that it should be considering other issues.
