We call on the National Assembly to work towards a new Wales where:-

- 1. the Welsh Language unites rather than separates us with everyone speaking Welsh, as the language belongs to us all, and each and everyone should have the same opportunities.
- 2. the Education System equips the young people of Wales with the knowledge, skills and experiences necessary to protect our local communities.
- 3. financial assistance is provided to promote Welsh Language Youth Culture so that our peers can be proud of their heritage.
- 4. there is a Welsh Language Radio Service managed by young people to act as a voice for our culture and as a forum for the discussion of new ideas.
- 5. there is a housing policy for young people in Wales so that it is feasible for us to choose to live in our communities.
- 6. there is an employment policy for our young people in Wales so that it is feasible for us to choose to work in our communities.
- 7. the ability exists to use the Welsh Language in all aspects of life in Wales.
- 8. there are Youth Councils, both nationally and at county level to scrutinise the work of the Assembly and the County Councils.
- 9. there is a statutory obligation for County Councils to consult the Youth Council before finalising Local Plans on the future of communities.
- 10. the Assembly sets a good example by operating totally bilingually and considers the effects of each policy on the young people of Wales.
