The Legal Adviser informed the Committee that another piece of legislation on the same subject (CA402 - The Safeguarding Vulnerable Groups Act 2006 (Controlled Activity) (Wales) Regulations 2010) has been signed and made by the Deputy Minister for Social Services. When considering this statutory instrument at its meeting 11 March 2010 the Committee was concerned that the Explanatory Memorandum to these Regulations stated that the Welsh Regulations were intended to come into force on 1 April 2010, subject to related regulations being made at Westminster. The Regulations had now been made.

### Other Business

# CA425 - The Natural Mineral Water, Spring Water and Bottled Drinking Water (Wales) (Amendment) Regulations 2010

The Committee reported these Regulations under Standing Orders 15.2 and also 15.3(ii) (on the grounds "that it is of political or legal importance or gives rise to issues of public policy likely to be of interest to the Assembly.") 25 March 2010. It was noted that the way in which the use of the Welsh language has been treated in legislation on this subject had been the subject of previous reports by the Committee and its predecessor under Standing Order 15.2 and 15.3. Although the Committee took oral evidence from the representatives of the Food Standards Agency Wales and the Deputy Director of the Legal Services Department of the Welsh Government, it was agreed to invite the Deputy Minister for Social Services Gwenda Thomas AM to seek further clarification.

The Committee took oral evidence from the Deputy Minister for Social Services, Gwenda Thomas AM. Having assured the Committee that she takes the issue of bilingualism in Wales very seriously and that the Food Standards Agency is committed to its Welsh language policy the Deputy Minister informed the Committee that she will make amendments to the principal regulations – "The Natural Mineral Water, Spring Water and Bottled Drinking Water (Wales) Regulations 2007" within the next two months to allow the use of Welsh descriptions. The Committee was content with the Minister's approach.
