**Background**

The Order to which this memorandum relates was laid before the Assembly on 2<sup>nd</sup> May 2001, considered by the Business Committee on 1<sup>st</sup> May 2001 and by the Legislation Committee on 15<sup>th</sup> May 2001.

The report of the Legislation Committee about the Order identified certain matters, being typographical, grammatical or minor drafting errors, as appropriate for correction under Standing Order 22.13.

The following amendments rectify those errors:-

**Article 2 and its heading**

Amendment 1: in the heading omit the letter "s".

Reason for the amendment: minor drafting error.
