1. Role and responsibilities

- **1.** The Culture, Communications, Welsh Language, Sport and International Relations Committee ("the Committee") is responsible for scrutinising the Welsh Government's approach to international relations, including the delivery of its International Strategy¹, and associated actions plans².
- 2. The Committee is particularly keen to ensure that the global profile of Wales does not diminish because of our changing relationship with the EU. We also wish to keep abreast of how the Welsh Government's international relations work overlaps and impacts other areas of the Committee's remit.
- **3.** This year, we agreed³ to start issuing annual reports on international relations to provide an overview of our work and draw out key themes in one place. Our first report summarises our activities.
- **4.** The Committee routinely considers the following matters:
 - Budget;
 - International relations priorities of the Welsh Government;
 - Implementation of the International Strategy, including activities of the
 Welsh Government's network of overseas offices;
 - Overseas visits and visitors; and
 - Relevant legislation, including legislation relating to international obligations.
- **5.** The Committee has undertaken proactive inquiries, including on:
 - Wales-Ireland relations⁴ (completed); and

- Culture and the new relationship with the EU⁵ (ongoing).
- **6.** The Committee also responds to:
 - significant international developments. For example, it signed a joint statement⁶ with other Senedd committees on the first anniversary of the Russian invasion of Ukraine; and
 - relevant consultations by other parliaments and institutions. For example, the House of Lords European Affairs Committee's inquiry on the UK-EU future relationship⁷.
- **7.** The Chair represents the Committee at relevant meetings held at the Senedd, such as the Conference of Peripheral Maritime Regions summit (CPMR), and in diplomatic meetings with visiting Ambassadors and dignitaries.
- **8.** Committee members also represent the Senedd in a number of relevant parliamentary bodies, including the EU's Committee of the Regions-UK Contact Group, the Commonwealth Parliamentary Association, and the Interparliamentary Forum on Brexit.
- **9.** We are not the only Senedd committee that considers international affairs. We work alongside the Legislation, Justice and Constitution Committee, the Economy, Trade and Rural Affairs Committee and others to ensure that international matters are considered and the Welsh Government's approach is scrutinised.

Improving transparency

10. The Welsh Government does not report on international relations in one place and there are limited requirements to provide information to the Senedd on the topic. During the Fifth Senedd, there was a dedicated Minister for International Relations but following the 2021 Senedd elections, the post was disbanded and the responsibilities subsumed by the First Minister⁸.

- 11. Since its establishment in June 2021, we have sought to ensure that information is regularly provided by the Welsh Government to the Senedd. This is to ensure that, between annual scrutiny sessions attended by the First Minister, there is no diminution of focus on international relations in the absence of a dedicated Minister.
- **12.** The First Minister is also invited to attend the Committee for scrutiny of the departmental budget of £8.38 million⁹.
- **13.** At our request, the Welsh Government agreed to provide the following information:
 - Monthly lists of overseas Ministerial visits and diplomatic visits to Wales.
 Prior to receiving these lists, the Committee relied on a number of different sources to monitor visits which presented challenges tin effectively scrutinising the Welsh Government's activities;
 - Annual activity reports of the Welsh Government's overseas offices;
 - Notifications of British-Irish Council meetings under the Inter-Institutional Relations Agreement¹⁰;
 - Specific information in response to Committee requests, including copies of correspondence, statistical requests and detailed information on specific aspects of our work.
 - At the Committee's request, the Welsh Government also launched a new webpage for international bilateral agreements¹¹, giving them parity with how equivalent domestic agreements¹² are presented on its website.
- **14.** We continue to make recommendations to the Welsh Government on ways it could further improve information in the public domain to improve scrutiny, assist interested parties and showcase its activities. For example our Wales-

Ireland relations inquiry report¹³, and our consultation response to the House of Lords European Affairs Committee inquiry into the future UK-EU relationship¹⁴, makes recommendations on these issues.

Conclusion 1. We welcome steps taken by the Welsh Government to increase and improve information available in the public domain on international relations, such as the international bilateral agreements webpage established on the Committee's request.

2. Budget

- **15.** The Committee carries out annual scrutiny¹⁵ of the Welsh Government's draft budget for international relations work.
- **16.** In relation to the last draft budget (2023-24), we noted that, like many budget lines, the International Relations budget is not immune from challenges presented by inflation, the cost of living increases or the war in Ukraine.
- 17. The departmental budget of £8.38 million¹⁷ was to be maintained in 2023-24 but inflation means that this amounts to a real term cut for the overseas offices which makes the prioritisation of activity important.
- **18.** We expressed our disappointment that the First Minister:
 - would not give oral evidence¹⁸ and would instead provide written responses to our questions; and
 - was unwilling to commit to sharing outcomes and outputs that will be delivered by draft budget allocations to support the International Strategy and actions plans. We explained our rationale for the request for this information, including that it would improve its understanding and would provide assurance to Committee Members and stakeholders that spending in this area would be targeted, effective and deliver value for money. We asked the First Minister to reconsider this request.
- **19.** We will next undertake budget scrutiny in January 2024, and have invited the First Minister to give oral evidence.¹⁹

Recommendation 1. We repeat our request and reiterate our statements made during the previous draft budget, that more detailed information is provided to the Committee to assist its scrutiny. This should include details of the outcomes and outputs that will be delivered by draft budget allocations to support the Welsh Government's international relations work, including delivery of the International Strategy and its action plans.

Recommendation 2. We call on the First Minister to provide oral evidence in person for draft budget scrutiny.

3. International Strategy

20. The Welsh Government does not report specifically on its International Strategy (2020-25). However, the Committee monitors international relations activity for progress using a combination of Welsh Government overseas office reports, Ministerial statements, and evidence sessions, Senedd business and social media.

Refresh

- **21.** During our annual scrutiny session with the First Minister²⁰ in May 2023, the First Minister announced that the International Strategy will be refreshed when it expires in 2025 to cover the remaining time before the 2026 Senedd elections.
- **22.** In 2022, the Committee asked the First Minister to explain the process by which the Strategy would be refreshed as 2025 approaches, he said:

"Absolutely happy to have that sort of discussion [with the Committee]— set it out on paper to begin with, and then at a future occasion to discuss it, if that was useful."²¹

Programme for Government

- **23.** The Welsh Government's Programme for Government²² includes commitments to "give our country the strongest possible presence on the world stage". The Programme for Government, which was first published in 2016 and updated in 2021, does not mention the International Strategy.
- 24. Three additional commitments are set out to:
 - 1. Establish a Peace Academy Academi Heddwch in Wales;

- 2. Put in place a £65 million international learning exchange programme; and
- 3. Reinvigorate our twinning relationships across the EU through a Young People's Twinning Fund.
- **25.** International matters, like biodiversity, refugee policy and incorporating treaties into Welsh law are threaded throughout the Programme for Government and will also play an important part in Wales's international relations.
- **26.** We will monitor progress²³ against these Programme for Government commitments.

Conclusion 2. We welcome the First Minister's offer to discuss the refresh of the international strategy with the Committee. The proposed approach will provide an important opportunity for the Committee to input its view and findings from the Sixth Senedd into the refreshed International Strategy.

Conclusion 3. We encourage the Welsh Government to extend this invitation to other interested parties, including stakeholders.

Recommendation 3. We request a progress update against the short and medium term actions listed in the International Strategy's actions plans.

Overseas office network

- 27. The Welsh Government's:
 - annual reports on its overseas network²⁴; and
 - overseas office remits document²⁵,

form key parts of the Committee's international relations scrutiny.

- **28.** In April 2023, we visited the Welsh Government's Dublin office as part of our Wales-Ireland relations inquiry²⁶, where Members met with staff to better understand its day-to-day operation.
- **29.** Members of the Committee also regularly visit the Welsh Government's Brussels office in their capacity as Senedd representatives on post-Brexit UK-EU bodies, such as the Parliamentary Partnership Assembly²⁷ and EU's Committee of the Regions UK Contact Group²⁸.

Conclusion 4. We welcome the publication of overseas office activity reports and office remits document by the Welsh Government and encourage the Welsh Government to provide sufficient detail in these outputs for scrutiny.

4. Priority relationships

30. The Welsh Government's International Strategy sets out its priority relationships:

"Country: Germany, France, Ireland, US and Canada Regions: Basque Country, Brittany and Flanders."

Bilateral agreements

- **31.** The Welsh Government has a number of active international bilateral agreements in place with Quebec, Brittany, Basque Country, Ireland, Oita Prefecture and Flanders.
- **32.** As a result of the our work, these are listed on a dedicated Welsh Government webpage. We will continue to monitor the conclusion of international bilateral agreements by the Welsh Government.

Wales-Ireland relations

- **33.** The Welsh Government's International Strategy identifies Ireland as a priority country relationship. Both governments have signed a Shared Statement and Joint Action Plan²⁹ outlining how they will cooperate on shared policy areas.
- **34.** This is the Welsh Government's most developed strategic international relationship with another country and its government, with structured engagement mechanisms, strategic objectives and specific actions.
- **35.** We conducted an inquiry³⁰ into this relationship and published our report³¹ on 5 October 2023.

36. We look forward to see the results of this work develop, including our own commitment to strengthen ties with our sister committees in Ireland's Oireachtas.

UK-EU relations

- **37.** It is clear that the UK-EU relationship remains an important priority for the Welsh Government and for stakeholders in Wales. We have made a number of observations in this area, including that:
 - the absence of dedicated strategies to UK-EU relations at a UK- and Wales- level presents challenges when navigating, and providing effective scrutiny of, the post-Brexit UK-EU relationship. This is compounded by the breadth of Ministerial responsibilities at Welsh Government³² in delivering the new arrangements.
 - the nature of UK-EU relations could impact the delivery³³ of the Welsh Government's international strategy and Wales-EU relations more generally.
 - the four nations should be engaged and represented³⁴ in future UK-EU relations.
 - We continue to believe in the importance of direct contact³⁵ between devolved governments and legislatures with EU institutions.
 - We are concerned that the post-Brexit challenges faced by stakeholders to engage in UK-EU relations has led to reduced³⁶

representation of Welsh interests³⁷, which could reduce further in future.

- Wales has a direct interest in the Northern Ireland Protocol³⁸, including on all matters affecting Welsh businesses and NI-GB trade flows given the strategic importance of its west-facing ports.
- We welcome the conclusion of the Windsor Framework³⁹ and the potential opportunities it unlocks, particularly with respect to the UK's association to Horizon. Prior to its conclusion, we called the UK and EU to urgently seek a negotiated solution⁴⁰ to the issues raised by the Protocol.
- **38.** The Committee pursues these matters on an ongoing basis, including during our annual scrutiny session with the First Minister⁴¹ in May 2023.
- **39.** In relation to the refresh of the International Strategy in 2025, the First Minister told⁴² the Legislation, Justice and Constitution Committee on 18 September that:

"...there may be opportunities to make the European dimension of [the refresh] a bit more explicit." [paragraph 105]

40. The First Minister also set out his strategic forward approach to the EU⁴³ in correspondence to that Committee on 6 October.

5. Overseas visits and visitors

- **42.** The Committee receives monthly lists of overseas Ministerial visits and incoming diplomatic visits to Wales.
- **43.** Costs for 2021-22 were published on 15 December 2022, totalling £10,406.34. In March, the First Minister responded⁴⁵ to written requests for costings in relation to two Ministerial visits, to Paris and Brussels in March 2023. In response, the First Minister said costs would be published after the end of each financial year in April but these have not yet materialised.
- **44.** The Welsh Government's Ministerial Code⁴⁶ requires that:

"Annually, a list will be published of all travel overseas by ministers costing more than £500 per trip, together with the total cost of all ministers' visits overseas." [paragraph 9.8]

- **45.** Paragraphs 9.2-9.10 of the Ministerial Code set rules for Ministerial visits overseas.
- **46.** Paragraph 5.22 also requires list of gifts and hospitality received by Ministers on behalf of the Welsh Government valued at more than £320 to be reported annually.
- **47.** The Committee is aware of multiple overseas Ministerial which are likely to meet these reporting requirements and we will continue to monitor overseas visits.

Recommendation 9. We call on the Welsh Government to clarify when costs related to overseas travel will next be published.

Recommendation 10. We call on the Welsh Government to publish costs in accordance with the commitment made by the First Minister to publish the latest costs after the end of each financial year.

Recommendation 11. We call on the Welsh Government to ensure the accuracy of the lists of overseas visits and visitors.

6. Legislation

48. The Committee considers legislation relating to international relations, as follows.

Legislative Consent

49. We were tasked with scrutiny of the following Legislative Consent Memorandums (LCMs)⁴⁷:

Northern Ireland Protocol Bill

50. In our report⁴⁸, we:

- Raised concerns the Bill poses a risk to the UK's international reputation and its credibility in international law;
- Raised concerns that the Bill marks a deterioration in UK-EU relations which could in turn impact the delivery of the Welsh Government's International Strategy, Wales-Ireland cooperation, and Wales-EU relations. We urge both parties to urgently seek a negotiated solution to the issues raised by the Protocol;
- Agreed with the Welsh Government's view, that Wales has a direct interest in the Protocol, including on all matters affecting Welsh businesses and NI-GB trade flows given the strategic importance of its west-facing ports; and

Data Protection and Digital Information (No.2) Bill

51. In light of the potential risks outlined by the Welsh Government to the UK's EU data adequacy decision, our report⁴⁹ called on the Welsh Government to:

• provide regular updates to the Committee on the Bill's impact on UK-EU relations, including intergovernmental discussions on the Bill as it progresses through the UK Parliament and on an ongoing basis should it be enacted.

The First Minister's response⁵⁰ said that:

"I will continue to provide updates on the potential impact of the Bill on EU-UK relations through the LCM process, in particular regarding concerns around the EU's data adequacy decision, until such time that I am content that the Bill will not impact on EU data adequacy."

Conclusion 6. The Committee welcomes this commitment.

52. The response also provided the Welsh Government's assessment of the Bill against specific provisions of the UK-EU Trade and Cooperation Agreement⁵¹. We found this particularly informative in its scrutiny of matters raised in the Bill.

Recommendation 13. The Committee calls on the Welsh Government to routinely include detailed analysis of the Trade and Cooperation Agreement where UK-EU matters are cited in their Legislative Consent Memorandums, as provided during the course this Bill's scrutiny.

International treaties

53. We consider treaties drawn to our attention by the Legislation, Justice and Constitution Committee which has a dedicated process for treaty scrutiny⁵². That Committee notifies other Senedd committees of treaties agreed by the UK Government that fall within their remits.

54. The First Minister recently welcomed our interest⁵³ in international agreements during our consideration of the Council of Europe Convention on an Integrated Safety, Security and Service Approach to Football Matches and Other Sporting Events.
